Managers, coaches will NOT have the authority to reschedule ice without going to the respective commissioner first.

1. New Business

- a. U7/U9 Net approval.
 - i. Eric has done some research and got a quote for nets. Atomic has given is a price of \$1300.00 for Windwell nets.

The second quote Is from a reputable online site. 4 nets would cost \$2745.56. Keeping the new rink in mind this company also does packages with half ice boards included. This may be a better option as we will need these for the new rinks once completed. Board has decided to table this till the new year.

- b. There has been a request for a U7 player to be moved up to U9. The board has denied this request. Board has considered revising the AP rule with player development in mind. Eric will revise this and send to the board for approval.
- c. MLMH was quoted \$60.00 an hour for dryland space in the new gym attached to the rink. MLMH would like to see if there is a better rate available or possibly and added cost to our allocated ice to accommodate for use of dryland space at flying dust gym. Jill has offered to look into this with the recreation manager.
