2. Review of Previous Meeting Minutes: Thomas motions to approve. Sandi

seconds. All in favour

3. **President's Report:**

- Diamond maintenance progress Jeff met with the town but still needs to meet with Rob to go over details. There was some damage to the dugout after a U18 Leduc game. Jeff has reached out to their president and they said they would make it right.Bottle drive/picture day preparations. Maps have been issued. Concession will be open. Anyone have trailers they are willing to provide to help with bottle transfers to Beaumont?
 It will be put out to teams. Kim motions that a \$50 gift card be purchased per trailer that helps with the bottle drive. Melanie seconds. All in favour.
- Uniform/Jersey Allocation progress. Final inventory of jerseys There is still 2 teams left to get their jerseys.
- Highlights regarding the meeting with Lisa Novotny (Town of Millet)
 - The town has suggested we use the Wellness group for youth activities as much as possible. Try Baseball Day can be an even run in their facilities as long as it's not only for association members
 - They have also suggested that we try to apply for their grant that would help pay
 for buses and promote ticket sales to the Riverhawks games. This can be done
 multiple times and include local youth, seniors etc.
 - The town has also suggested we utilize the new started (but not quite effective yet)
 Mass Notifications Service
 - Lisa has also stated that anytime after the Town Budget is approved in September, we will be able to find out at that point if diamond rentals will be going up.
- Concession progress. Waiting on draintech to provide water so we can test samples Kirk will haul in the water this year.
- There is the possibility of the Red Eye Tournament returning to Millet. This could offer some unique profit abilities for MMB. Once we have more information on this we will see to what capacity MMB will get involved.

6. Registrar Report:

- Registration is complete and closed. All the teams have been submitted to BA on April 10th. There have been a couple of hiccups on their end, but everything has been submitted. Blackout dates have not been asked of me or an option for me to give.
- Volunteer signup has been going fairly smoothly for the most part. Trying to link parents to kids has been the biggest problem. About 85% have signed up already with the stragglers





being Rallycap and U9. I plan to talk to the tournament committee/coordinator and see if we reach out again or just start assigning positions to people to cover.

7. Coach & Player Development's Report:

- Was asked to redo the deck quote for replacing the existing deck. I took the original quote and divided by 4. It's roughly 1/4 the size of original so if we all except it we could have deck done for \$1000
- Only issue is since the original quote it is my busy season and I have baseball to go along
 with my already extremely busy schedule. I recommend we spend \$150 on sheets to
 resurface the deck and let it last for the season and this can be a project I tackle in fall or
 next spring. Tyson motions \$200 for immediate repairs to hold us over as there isn't
 much time left to get the full project complete. Thomas seconds. All in favour.
- Also I paid Mason \$480 for his services for the clinics. We ran 2 extra hours. I received money from u18 and u15 but not u13 yet. (Kirk) we had a total of 28 kids involved in clinics. Looking for a \$200 reimbursement for the extra fees paid to Mason. - Tyson motions \$200 reimbursement. Thomas seconds. All in favour.

8. Equipment Coordinator's Report:

- A robust tee for the u18 to smack around has been bought, it's \$139 for the Rawlings MVP, all hard metal pieces and a wrapped cone so it should stay in good shape.
- Portable tees (tripod style) x3 are also available inside the sea can. These are meant to fit in team bags
- New score sheets and player lineup books are in the sea can
- Roml balls and 80cc are separated, may need another round of balls before end of the season but basically got a box per team to start.
- Boxes of ice packs are available in the sea can, take 10 from here for your bags if you like. There's 50 total I think.
- 2 more med kits bought with hard walls for travel in game bags, still looking for the best price on level 3 kit for concession stand.
- Pitching screens like the ones Tyson bought are next, just wanted to make sure I
 got everyone's needs in order before buying one. You all want travel screens,
 correct?





- Some screens and tees were found in the seacan. New coaches mask has been purchased.
- So far we are under budget, likely because of the missing u11 team. I may invest some of it into another robust tee for the kids to use, if it's a good product.

- A new double deep fryer has been purchased
- Will be open for a soft opening on picture day with a reduced menu.
 - Sandi motions a \$1500 budget for the initial haul in order to open on picture day. Kirk seconds. All in favour.
