



COVID-19 Conditions of Use Ice Pad

These conditions are in addition to those listed within the Ice Pad Rental Contract. The rental agreement holder is required to share all conditions of use with all participants.

Groups are responsible for following established health and safety protocols, including provincial guidelines, guidelines established by the Municipality of West Perth and their sport's governing body.

In accordance with provincial legislation, all leagues must submit a copy of their COVID-19 safety plan to the Municipality prior to the start of the 2021-2022 ice season.

Vaccine Mandate

As of **Wednesday, September 22, 2021**, all participants, coaches, and spectators under Provincial Section 22 orders under the Health Protection and Promotion Act must have proof of full vaccination status to enter indoor facilities owned and operated by the Municipality of West Perth. Proof of vaccination (as seen below) must be issued through the Ontario Ministry of Health and presented alongside a valid piece of ID.

Exemptions:

- Children under 12 years of age.
- **Patrons under 18 years of age who are entering the facility for the purpose of actively participating in an organized sport.**
- Patrons with a written document by a physician or nurse practitioner, stating that they are exempt for a medical reason from being fully vaccinated against COVID-19 and the effective time period.

Health Screening

Please have all participants and spectators of your rental complete an approved active screening before entering any Municipality of West Perth facility. Please see an example of active screening questions below:

1. Do you have any of the following new or worsening symptoms:
 - a. Fever (= or > 37.8C) / chills
 - b. Cough
 - c. Difficulty breathing / shortness of breath
 - d. Sore throat, trouble swallowing
 - e. Runny nose (unrelated to allergies)
 - f. Loss of taste or smell
 - g. Not feeling well, headache, unexplained tiredness & muscle aches
 - h. Nausea, vomiting, diarrhea, abdominal pains
2. Has a doctor, health care provider, or public health unit told you that you should currently be isolating (staying at home)?
3. Have you been identified as a “close contact” of someone who currently had COVID-19 in the last 14 days?
4. Have you received a COVID Alert exposure notification on your cell phone in the last 14 days (and have not been tested or waiting for your result)?
5. Have you or anyone you live with travelled outside Canada in the last 14 days?
6. Is anyone you live with currently experiencing any new COVID-19 symptoms and/or waiting for test results after experiencing symptoms?

If you answered YES to any of the above questions, PLEASE DO NOT enter this location AND contact your health care provider.

Personal Hygiene

Participants should practice proper hand hygiene techniques often. All patrons will be expected to use the hand sanitizer stations located around the facility.

Proper respiratory etiquette should always be followed (spitting is prohibited).

Gathering Limits

The maximum number of people permitted on the ice is **150**. This includes players, coaches and trainers. Physical distancing guidelines must be followed whenever possible.

The maximum number of spectators allowed in the facility at one time is **200**. Physical distancing guidelines must be followed whenever possible.

Attendance

Attendance (names and contact information) must be taken for all participants, spectators and coaches. This information must be kept for at least one month and available to the Municipality of West Perth in the event of an outbreak.

Equipment

Participants are encouraged to bring their own equipment. Any shared equipment must be sanitized between uses.

Each association is to use their designated storage area for all equipment stored over the season. It is the association's responsibility to clean and sanitize all equipment stored at the West Perth Community Centre.

Arrival and Departure

Please follow all signage posted outside and inside the facility.

Anyone entering the facility is required to wear a face covering. Players can remove face coverings before entering the ice pad.

Participants are asked to arrive no more than 30 minutes before their scheduled ice time and to leave within 30 minutes of the conclusion of their ice time.

Participants and spectators should enter the facility through the main arena doors off the parking lot. Players can make their way to the appropriate dressing room, according to the dressing room schedule on the television inside the doors.

Dressing Room Capacities

Room 2, 3 and 4	13 ea.
Room 5, 6 and 7	17 ea.

Spectators are asked to stay within the facility during the hour of ice.

Amenities

All facility washrooms will be open to participants and spectators for use. Participants are asked to use the washroom within their assigned dressing room. Shower facilities within dressing rooms will be available for use.

The concession booth will be open to the public, starting in October.
