

## **COVID-19 INFORMATION FOR PARTICIPANTS, COACHES & OFFICIALS**

- Participants should proactively and regularly monitor for symptoms. <u>SYMPTOMATIC INDIVIDUALS ARE</u> <u>PROHIBITED FROM PARTICIPATING AND ENTERING THE FACILITY.</u>
- The Legal Arena will promote physical distancing by indicating one-way traffic flow to avoid individuals from inadvertently interacting. Common areas must not be used to congregate.
- > Hand sanitizer (60% alcohol or higher) will be available at entry and exit points in the Legal Arena.
- Face coverings are strongly recommended while inside all areas of the Legal Arena not including while on the ice surface. To the extent possible participants should:
  - Refrain from touching their eyes, nose, mouth, and face during activities.
  - Practice sneeze/cough control and respiratory etiquette.
  - Refrain from spitting and clearing their nasal passages during activities.
- Limit group celebrations and other customs during activities (e.g., handshakes, high fives, fist bumps, chest bumps).
- > All patrons will:
  - Enter the Legal Arena through the MAIN ENTRANCE DOOR; and
  - Exit through the SOUTH EAST SIDE DOOR.
- The coach/designate must check in with facility staff to sign in their team and confirm health screening for the team is clear (Health screening is the responsibility of the coach/designate).
- Participants are to arrive no more than 15 minutes before their booked ice slot and should check the Dressing Room Assignment Board to see what dressing room is allocated to their team. They must go directly to their assigned dressing room.
- > Participants are encouraged to arrive dressed and ready to participate in their activity.
- Inside the Dressing Rooms:
  - Coaches, players and authorized team personnel ONLY
  - Access to toilets and sinks are available
  - No showering
  - No food
- > Participants are to leave the facility after your booked time.
- > Officials are encouraged to come dressed for their activity.
- No more than 50 people can be on the ice and in player's boxes at the same time. This includes referees and coaches.
- Please report any injury or accident immediately to the facility staff, including when emergency services have been contacted.
- Please respect all signage in the facility.

## **COVID-19 INFORMATION FOR SPECTATORS**

- Spectators should proactively and regularly monitor for symptoms. <u>SYMPTOMATIC INDIVIDUALS ARE</u> <u>PROHIBITED FROM PARTICIPATING AND ENTERING THE FACILITY.</u>
- The Legal Arena will promote physical distancing by indicating one-way traffic flow to avoid individuals from inadvertently interacting. Common areas must not be used to congregate.
- > Hand sanitizer (60% alcohol or higher) will be available at entry and exit points in the Legal Arena.
- Face coverings are strongly recommended while inside all areas of the Legal Arena by all spectators. Practice sneeze/cough control and respiratory etiquette.
- > All patrons will:
  - Enter the Legal Arena through the MAIN ENTRANCE DOOR; and
  - Exit through the SOUTH EAST SIDE DOOR.
- > Spectators will arrive no earlier than the scheduled sporting time.
- Up to a maximum of 50 seated spectators are allowed inside the Legal Arena. Spectators are to proceed directly to bleacher area.
  - Bleacher assignments will be posted in lobby with Dressing Room Assignments.
  - Bleacher areas will be used alternately between groups/ice slots to allow for proper sanitizing between users. Please obey directional signage.
  - Spectators are to remain seated in designated bleachers for the duration of the event.
  - Cheering and yelling is strongly discouraged at this time as it presents a high risk of spreading droplets that could contain the Coronavirus.
- Limit group celebrations and other customs during activities (e.g., handshakes, high fives, fist bumps, chest bumps).
- Once your team has finished their game/practice, immediately exit the facility. If you are meeting a team participant, please wait for them outside the facility.
- Please report any injury or accident immediately to the facility staff, including when emergency services have been contacted.
- Please respect all signage in the facility.
