Distancing Measures

Considerations:

How will you ensure people maintain 2 metres between each other?

Spectators must follow all AHS, MMSC guidelines on distancing. MMSC members must keep physical distance of 3 meters from others not in their household.

How would you limit congregating (e.g., in break rooms, communal spaces, rest areas, etc.)?

There will be no congregating anywhere on the Town of Morinville's property. All coaches will meet all players at the the sidelines on the fields following the field setup. Parents/guardians go straight to the spectator area. Players must come fully dressed and ready to train. As soon as the soccer activity is over all spectators must leave the soccer field immediately. Coaches will bring all children to their parents at the spectator area.

How will you limit the overall number of people in your space? Refer to the Personal Protective Equipment (PPE) section to mitigate the risk of transmission when 2 metre distancing cannot be maintained.

MMSC encourages one parent/guardian per player/family to attend to minimize the amount of people. While following all AHS outdoor social gathering restrictions.

Participants are made into smaller groups while following AHS and Alberta Soccer Association guidelines.

Cleaning/Disinfection

Considerations:

How will cleaning on high touch surfaces be maintained in your location (e.g., bathroom, chairs, doorknobs, break rooms)?

All high touch surfaces are cleaned by coaches following out cleaning and sanitizing guidelines.

How will you train and ensure workers or volunteers keep equipment clean?

One coach will be responsible of setup and taking down and cleaning of equipment before and after every session, with no sharing with other teams or players. We will hand out cleaning guidelines to all coaches with directions with how to clean/disinfect equipment.

What cleaner are you using?

How long do you have to keep the disinfectant on the surface for it to be effective?

10 minutes then wipe off

Screening for Symptoms

Considerations:

How will you be aware of symptoms in attendees, such as fever, sore throat, cough, runny nose or difficulty breathing?

Parents/guardians/coaches/players will have to do the self assessment COVID-19 screening questionnaire provided for self monitoring, they will have to check in with the coaches and let them know that their children are cleared to play.

Have you provided education or communication of self-monitoring of symptoms?

We have the AHS self monitoring assessment tool. This checklist will be on our website and emailed to each parent.

Have you identified a space where attendees can be separated from others if they develop symptoms?

Each field will have a dedicated quarantine area for anyone showing any symptoms that is out of the way from anyone else out on the fields.

Have you considered what you would do if you see increased absenteeism due to illness or isolation requirements?

We would call the parents of the child who has missed 2 or more practices without communicating to our coaches of absenteeism for a wellness check.

Have you considered absenteeism policies that encourage staff members or volunteers to stay home when ill, in quarantine (self-isolation), or if they are taking care of children or someone who is ill?

We would remind the volunteers/coaches to follow all AHS guidelines.

Are you maintaining a log of staff or volunteer attendance?

Each coach will be given a log in sheet to track attendance and clearance to play. This log must be submitted to admin@morinvilleminorsoccer.ca

What is your response plan for staff who come to work with symptoms?

Absolutely NO ONE is to come to the field with any symptoms of Covid-19. We require all members to follow all AHS guidelines of self isolating for 10-14 days, a negative Covid-19 test and/or until all symptoms are gone whichever is later.

Personal Protective Equipment (PPE)

Considerations:

How will you promote PPE use (e.g., masks or gloves) when people are unable to be 2 metres apart?

Spectators must wear masks if they cannot maintain a min of 3 meters distance.

Coaches must wear masks on the fields at all times.

If 2 metres cannot be maintained and PPE is necessary, where would you obtain it?

Masks are the responsibility of each individual entering onto the field.

Responsibilities

Considerations:

Who will be responsible for ensuring staff, customers, congregants and volunteers are following your precautions?

The Coach is responsible for all players following all precautions. All members must follow all AHS rules and regulations.

Have you updated contact information for staff and volunteers so they can be notified in the event of a known exposure?

All information is given to the appropriate director of all contact information.

What would your approach be if you had to manage a situation where there was apparent non-compliance with your plans/direction?

The individual would be sanctioned and removed from MMSC. Depending on the situation the Town of Morinville and/or the local law enforcement will be involved in accordance with the Emergency Act of Alberta.
