



## Mount Pearl Soccer Hall of Fame By-Laws (Revised May 27, 2015)

- Article 1 Name**  
Mount Pearl Soccer Hall of Fame
- Article 2 Location**  
Mount Pearl, Newfoundland and Labrador
- Article 3 Objective**  
To recognize, honor and pay tribute to individuals who have made exceptional achievements and/or contributions to soccer within or for Mount Pearl Soccer
- Article 4 Administration**  
The affairs of the Mount Pearl Soccer Hall of Fame shall be the administered by the Mount Pearl Soccer Association
- Article 5 Finances**  
The Cost of the Mount Pearl Soccer Hall of Fame shall be the responsibility of the Mount Pearl Soccer Association
- Article 6 Classification of Members**
- 6.1 There shall be four (4) categories of membership in the Mount Pearl Soccer Hall of Fame:
- i) Player
  - ii) Builder
  - iii) Player – Builder
  - iv) Team
- 6.2 A Player is defined as an individual who has competed as a competitor in soccer organized by the Mount Pearl Soccer Association.
- 6.3 A Builder is defined as an individual who has made a major contribution towards the promotion, development and advancement of soccer in Mount Pearl, NL.

- 6.4 An Player – Builder is defined as any individual who has combined competition with contribution towards the promotion, development and advancement of soccer in Mount Pearl, NL.
- 6.5 A Team is defined as a Mount Pearl Soccer Association (MPSA) team which has medaled at Canadian Soccer Association (CSA) National Championship. (Gold, Silver or Bronze)

## **Article 7 Hall of Fame Committee**

- 7.1 The Chair of the Hall of Fame Committee will be a current member of the MPSA Executive shall be elected by the Executive of the Mount Pearl Soccer Association.
- 7.2 The Hall of Fame Committee shall consist of two sub-committees. One, being a Selection Committee with no less than 3 members, and two, a Nomination Committee, with no less than 3 members.
- 7.3 The members of the Selection Committee shall consist of people who are knowledge in the history, traditions, accomplishments, ability, skill, achievement, and contributions within the soccer in Mount Pearl, NL.
- 7.4 The members of the Selection Committee shall be appointed by the Executive of the Mount Pearl Soccer Association, and serve at the pleasure of the Association Executive, for a three year term.
- 7.5 The members of the Nomination Committee shall consist of people who are knowledge in the history, traditions, accomplishments, ability, skill, achievement, and contributions within the soccer in Mount Pearl, NL.
- 7.6 The members of the Nomination Committee shall be appointed by the Executive of the Mount Pearl Soccer Association, and serve at the pleasure of the Association Executive, for a three year term.
- 7.7 Members of the Selection Committee are not permitted to nominate any player, builders, athletes, or teams to the Nomination Committee
- 7.8 Any member of the Selection Committee who may be in a conflict of interest will have to resign from the Selection Committee
- 7.9 The Hall of Fame Committee shall include an Honorary Life Member sub – committee, to be responsible for the review, selection, and induction of any potential candidates to the status of Honorary Life Member.
- 7.9.1 The sub-committee shall consist of 3 persons:

Chair – Chair of the Hall of Fame Committee  
2 people appointed by the MPSA Board, on recommendation from the  
HoF committee  
(May 27, 2015)

**Article 8 Eligibility for Election**

- 8.1 To be nominated for the Mount Pearl Soccer Association Sports Hall of Fame, one's contribution must have been on a volunteer basis
- 8.2 Builder nominees may be either active or inactive.
- 8.3 Player – Builder nominees must meet the requirements of (1) and (2) to be eligible for election.
- 8.4 Members of the Selection and Nomination Committees shall not be eligible for election while serving on the Mount Pearl Soccer Association Hall of Fame Committee
- 8.5 A Maximum of 2 members may be inducted in any one year.
- 8.6 The Executive of the Mount Pearl Soccer Association may grant upon request from the Selection committee permission to select more than Two (2) candidates if deemed necessary.
- 8.7 A nominated candidate who is not selected in a particular year will remain in the pool of nominated candidates.
- 8.8 The MPSA HoF Committee is responsible for the nomination of candidates to the NLSA Hall of Fame, NL Sport Hall of Fame, and the MP Sports Alliance Hall of Fame.
- 8.9 The MPSA HoF Committee may only nominate to External Halls of Fame (ie, NLSA, Sport NL, and MP Sports Alliance Halls of Fame) nominees who have been inducted to the MPSA Hall of Fame

**Article 9 Publication of Election**

- 9.1 When possible each newly elected member of the Mount Pearl Soccer Hall of Fame shall be formally inducted at an official induction ceremony.
- 9.2 The time and place of such ceremony shall be determined at the discretion of the MPSA upon recommendation of the Hall of Fame Committee.

- 9.3 At the time of the induction, the new member shall receive a form of recognition as the Executive of the Mount Pearl Soccer Association deems appropriate.
- 9.4 The Mount Pearl Soccer Association shall be responsible for establishing and maintaining permanent biographies and photos of all Hall of Fame members and an updated website.
- 9.5 The deadline for the Nomination Committee to submit nominees to the Selection Committee will be six (6) weeks prior to the Induction ceremony.

**Article 10 Amendments to the By-Laws**

- 10.1 All amendments to the Mount Pearl Soccer Hall of Fame By-Laws must be approved by the Executive of the Mount Pearl Soccer Association.

**Article 11 Nomination Committee – Terms of Reference**

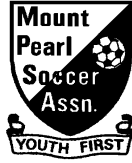

#### Part A - Builder

While there is a significant judgment factor, the Committee attempts to, where possible, assess nominations on the basis of the hard facts submitted by the Nomination Committee. A brief outline for each criteria is listed below:

#### **Duration of Distinction and Scope of Involvement**

- 1 Was the nominee responsible for the initiating or the growing of soccer in Mount Pearl?
- 2 Outline years of personal contribution of the nominee in terms of significant events.
- 3 Attempt to list early contributions, and significant contributions of the nominee.

#### **Character and Sportsmanship**

- 1 Did the nominee invoke a sense of fair play
- 2 Did the nominee create an environment of honesty, integrity and encourage players and volunteers to participate?

#### **Advancement and Development**

- 1 Would soccer have survived without the contribution of the nominee?
- 2 Did the nominee carry the sport through its developing years?
- 3 Did the nominee carry the sport through difficult times?
- 4 Did the nominee have a reputation among his/her peers, public, and/or media as being a prime mover of soccer in Mount Pearl

#### **Level of Quality of Involvement**

- 1 How long was the nominee involved?
- 2 Did the nominee participate in a leadership role? (ie. Pres, VP, Exec member, etc..)
- 3 To what degree was the nominee responsible for the initiation of and the growing of soccer in Mount Pearl. (ie. Strong leadership, etc.)?

- 4 Did the nominee have a reputation for fair play and sportsmanship?

#### **Advancement and Development**

- 1 Would soccer have survived without the contribution of the nominee?
- 2 Did the nominee carry the sport through its developing years?
- 3 Did the nominee carry the sport through difficult times?
- 4 Did the nominee have a reputation among his/her peers, public, and/or media as being a prime mover of soccer in Mount Pearl?

#### **Level of Quality of Involvement**
