The UNDERSIGNED shall indemnify the Naismith Basketball Association, its officials, volunteers, employees and invitees against and hold the same harmless from any and all claims, actions, suits, proceedings, costs, expenses, damages, and liabilities, including solicitors fees, arising out of, connected with, or resulting from the use of the equipment, facilities, and all associated buildings, grounds, and services supplied by the Naismith Basketball Association. Such indemnities shall survive the termination of the agreement for any reason.
