During the 2022-23 season, the association had 8 house teams (U-9 to U18), FUNdamental group and our senior division with 4 teams. Total participants for the house league were 219.

We will be playing in the NOWHL again this year and already have had some discussions with how to improve on this season.

All the coaches and volunteers did a great job this year to provide a fun season for all the players involved.

e. Competitive Convenor

The association returned to pre-pandemic levels in 2022-23 with 8 competitive teams. All teams competed in OWHA leagues with the exception of the U9 team which will compete in an OWHA league in 2023-24. This represents a significant change with all teams always competing against other girls teams. Our competitive teams competed in both the northern and southern leagues with consensus for the future that the southern league is a better option for our teams. Kudos to our coaches and managers for navigating through the scheduling process to accomplish this task. One team had to be re-categorized during the season. 6 teams qualified for provincials and multiple teams had successful playoff runs and tournament successes.

After the recent completion of tryouts for the 2023-24 season, the competitive program is growing with ten teams rostered. With three teams in the U18 and U15 divisions, two teams in the U13 division and one U11 and a U9 team, an area for potential growth is the U11 group where in the past we have had two teams. A few notable items from this year's tryouts were the significant number of requests for playing up an age group and the increased number of players coming from other associations to play for our teams. Both were significantly higher than in recent years.

BY-LAW EIGHTEEN Association Team Names, Logos, Colors and Apparel

A. The NBDGHA official colours shall be Blue, Green and White.

B. All Competitive and House Teams shall be known as the NBDGHA Jr Lakers

C. The use of the **"NBDGHA Jr Lakers"** Logo shall be at the permission of the Association Executive.

D. All team apparel shall be purchased through the designated supplier as advised by the Association.

E. Only team apparel items which have been pre-approved by the Executive Committee shall be available for purchase. A team cannot request a non-approved item directly from the supplier.

F. Apparel contracts shall be reviewed on an annual basis by the Executive.

G. Only official Association colours and Logos shall be used, and apparel shall be suitable to the sport and age appropriate for the players.

NBDGHA has entered into an MOU with Nipissing University to assist with promoting growth and development of female hockey in Nipissing area. As such, NBDGHA will change its "nickname" to Nipissing Jr Lakers and wear colour blue, green and white.

AMENDMENT

In specific Section H - Convener of House Team Operations 23) Should not be a Head Coach of a House League Team within NBDGHA during their term of office. Should extenuating circumstances arise, the NBDGHA executives reserves the right to approve the Convener of House Team Operations as Head Coach while in their term. The executive reserve the right to approve a current executive member with no conflict to oversee issues within that division if necessary.

Section I - Convener of Competitive Team Operations

24) Should not be a Head Coach of a Competitive Team within the NBDGHA during their term of office. Should extenuating circumstances arise, the NBDGHA executives reserves the right to approve the Convener of Competitive Team Operations as Head Coach while in their term. The executive reserve the right to approve a current executive member with no conflict to oversee issues within that division f necessary.

Rationale for Changes:

Having a House Coach be the House Convenor and a Competitive Coach be the Competitive Convener is a conflict of interest for those positions. Changing this will lead to some transparency in these positions for our members.

With a small association at times, it can be faced with a low number in volunteers, this can lead to a loss of coaches or executives, however, still allows for transparency and equal opportunity.
