2021-2022 Competitive Coaching Application

PROCEDURES

The Association will be interviewing candidates for 2021-22 Competitive team Coaches by division: U-9 (Novice), U-11 (Atom), U-13 Secondary (Peewee), U-18 Secondary (Midget). U-13A, U-15AA, U15A and U-18AA coaches have been selected in a prior process. The deadline for applications is **July 19, 2021**. The Association will then interview candidates by division.

Example: The Association will interview and rank all U-11 applicants. The top ranked applicant, should they accept, will be named U-11 A Coach. At the conclusion of U-11 A team selections, the Selection Committee will remove all coaching applicants whose daughter was selected by the U-11 A team. The next ranked applicant will be named coach, should they accept, of the secondary team.

1. All applications must be received by **July 19, 2021**.
 2. Interviews will be held during the week of **July 26, 2021**. Any applications received with incomplete sections, missing information and/or without the applicant's signature will not be considered.
 3. **All applicants must also submit a coaching resume, yearly budget and parent handout (including season plan) by July 19, 2021.**
 4. Candidates for each position will be contacted for a possible interview.
 5. All candidates are also required to read and sign the Coaches Commitments and Expectation Policy. A copy will be available at the interview.
 6. If you are successful, and are awarded a team, you will also be required to provide the Association with a Criminal Records Check, proof of Speak Out/Respect in Sport, and proof of applicable coaching certifications. Once your team is selected, your staff will need to do the same.
 7. Competitive team tryout dates, times, and procedures will be determined/approved by the NBDGHA Executive.
 8. The number of players, skaters and goalies, signed to a final roster, will be determined by the NBDGHA Executive and will be based on registration and programming requirements.
 9. The registration of a competitive team (division and category) with the OWHA shall be determined by the NBDGHA Executive and the Coach of the team.
