2. Apparel Proposal

For the 2022-2023 season Paul proposed to create an in stock "core collection" for players and parents to purchase, have a new jersey design approved, and begin to introduce limited runs of less common styles in small quantities. Alternative jersey design and ideas were presented. Orders need to be placed by July 1 in order to be available for September.

3. New Jerseys

Available funding for the purchase of new jerseys was discussed. The association does not have the funds to pay for a set of jerseys for all teams in the association. It was suggested that competitive team players purchase their own jerseys.

An executive vote occurred in favour of competitive team players purchasing their own jerseys. The style will remain traditional with matching socks and contentious pricing. Replacing house league jerseys will wait but can be rolled out one division at a time starting with the higher levels first. Older jerseys can be sold off to help cover some costs.
