What Is ITP?

Independent Third-Party (ITP) complaint management provides a mechanism to address allegations of maltreatment and code of conduct violations in your organization. ITP Sport is an independent body that delivers case management services, investigation, adjudication, and dispute resolution that provides participants, regardless of the sport or geographical location, access to a fair, consistent, and due complaint resolution process that is aligned with the requirements of the UCCMS and Sport Canada.

What Are the Benefits to My Organization?

The main benefits of implementing this equitable process are the significant reduction in organizational risk and an increase in the trust of your participants in delivering a program that puts their safety first.



Abuse Prevention

Significantly reduce the risk of a child or any other abuse in your organization. Implementing this mechanism allows for a safe and confidential reporting of maltreatment while maximizing the chances of **resolution before escalation**.



Risk Management

Using an ITP is a proactive risk mitigation control that helps **minimize insurance and legal costs**. Implementing an ITP process is a sound strategy to manage financial, reputational, legal, and governance risks.



Conflict of Interest

Eliminate the conflict of interest in complaints resolution by utilizing a fair and due process administered by **independent experts**. ITP Sport reduces volunteer and staff fatigue in managing complaints, thus **freeing up capacity and resources** to focus on programming and positive deliverables.
