### 1.0 GENERAL RULES OF COMPETITION <br> 1.1 OVERVIEW

1.1.1 The rules in Section 1 apply to all Provincial Competitions managed by the Newfoundland and Labrador Soccer Association (NLSA). Specific rules governing individual competitions managed by the NLSA are outlined in separate manuals and can be found online at www.nlsa.ca.

### 1.2 GENERAL

1.2.1 The Competitions Committee is responsible for the management and control of all competitions.
1.2.2 The Competitions Committee is responsible for maintaining these Rules.
1.2.3 These rules are subject to all NLSA Policies and Bylaws; in any conflict the NLSA Policies and Bylaws take precedence.
1.2.4 Within the constraints of its Policies and Bylaws the NLSA, through its Competitions Committee, may make such temporary rules governing specific situations, not otherwise provided for, as are necessary to achieve the objectives of the NLSA.
1.2.5 Failure to comply with any of the requirements within these rules shall render any organization or individual subject to discipline.

### 1.3 ADMINISTRATION OF COMPETITIONS

### 1.3.1 Team Expectations

1.3.1.1 Situations involving infractions requiring disciplinary sanctions occurring while participating in any NLSA competition will be dealt with by the appropriate person having authority over the situation and the individual involved. Disciplinary sanctions shall be in accordance with the NLSA Disciplinary Code.
1.3.1.2 All incidents of property damage must be communicated to the NLSA Representative for the competition, verbally within one hour after damage is discovered, and followed up in writing within 24 hours.
1.3.1.3 Damage by a team to any property, other than his/her (their) own shall be the financial responsibility of and dealt with by the club.
1.3.1.4 All youth age players participating at any Youth or Senior Competition must be appropriately supervised by the team staff in accordance
with the guidelines set down by the NLSA. Clubs may add to this policy as needed. The NLSA Supervision Policy can be found online in the Risk Management Policy at www.nlsa.ca
1.3.1.5 Any player aged 10 or over whose last registration was outside the jurisdiction of Canada Soccer must request that the NLSA, through Canada Soccer, obtain the necessary International Transfer Certificate (ITC). Without this certificate, the player is ineligible to play in Canada. The fee per International Transfer is set by Canada Soccer and must be paid accordingly. Exchange students are eligible for International Transfers but may take longer.
1.3.1.6 For the purposes of these rules, a youth is any person under the age of 18, before January 1st of the current year of competition, participating in an NLSA youth or senior competition.

### 1.4 NLSA REPRESENTATIVE

1.4.1 The Chair of the Competition Committee will appoint a NLSA Representative for any competition including the Final Weekend of Challenge Cup and Jubilee Trophy.
1.4.2 Wherever possible the NLSA Representative should have no duties in the tournament other than acting as the NLSA Representative.
1.4.3 The NLSA Representative will convene a meeting, if deemed necessary, of team representatives immediately prior to the competition.
1.4.4 The NLSA Representative will be responsible for the competition plaque or trophy and any medals or awards supplied by the NLSA. At the end of the competition s/he is responsible for returning unused medals to the NLSA office.
1.4.5 The NLSA Representative is responsible for all areas of discipline at the Provincial Tournament and will convene and chair a Competition Discipline Committee, if necessary. Appropriate action will be taken if deemed necessary.
1.4.6 The NLSA Representative shall investigate any general complaint prior to laying any charges of misconduct with the exception of anything arising from a referee's report on a game sheet.
1.4.7 The NLSA Representative will keep track of scores and standings.
1.4.8 The NLSA Representative will present or arrange for the presentation of the competition plaque or trophy, and any medals or awards supplied by the NLSA.
1.4.9 The NLSA Representative will ensure that any NLSA Board Members who are present and all NLSA sponsors are recognized during all ceremonies and awards presentations.
1.4.10 The NLSA Representative will be the final authority on all procedural matters not covered in these Rules and Regulations.

### 1.5 NLSA OFFICE

1.5.1 The NLSA Office must inform the host club and/or region of the teams participating in the competition.
1.5.2 The NLSA Office will provide the host club and/or region all online information pertaining to the tournament.
1.5.3 The NLSA Office will be responsible for providing medals and a championship plaque or trophy for each competition as required. All awards will be handled by the NLSA Representative for the competition.

### 1.6 NLSA POLICIES

### 1.6.1 Code of Conduct and Ethics

1.6.1.1 The NLSA has a Code of Conduct and Ethics, which must be adhered to by all members of The Association can be found online at www.nlsa.ca
1.6.1.2 All complaints received from members of the NLSA under this Code must be sent to the NLSA Judicial Body ethics@nlsa.ca for resolution

### 1.6.2 Volunteer Screening

1.6.2.1 The NLSA has a formal policy in regards to Volunteer Screening and can be found online at www.nlsa.ca.
1.6.2.2 The NLSA requires that any team official listed on the Team Credential Form for teams participating in any Provincial Youth Competition or in any Senior Competition when youth are members of the team or in any Competition, leading to a National to be Enhanced Police Information Check (E-PIC) cleared. For this purpose, a E-PIC clearance is valid for a maximum of 12 months.
1.6.2.3 The Association requires that any team official listed on the Team Credential Form for teams participating in any Provincial Youth Competition or in any Senior Competition when youth are members of the team or in any Competition leading to a National to have completed Respect In Sport and Safe Sport. For the purpose of these rules Respect In Sport is valid for a period of 5 years. The link for Respect In Sport is available on the NLSA website at www.nlsa.ca

### 1.6.3 Alcohol, Banned and IIlegal Drugs

1.6.3.1 The NLSA has zero tolerance in regards to the acquiring, possessing, purchasing or consumption of alcohol and banned and illegal drugs for all youth players playing in any NLSA sanctioned event. Such matters will be forwarded to the NLSA Judicial Bodies and may result in sanctions.
1.6.3.2 The NLSA has zero tolerance in regards to the acquiring, possessing, purchasing or consumption of banned and illegal drugs for all senior players playing in any NLSA sanctioned event,
1.6.3.3 A list of banned drugs can be found on the Canadian Centre for Ethics in Sport (CCES) website.

### 1.7 DISCIPLINE

### 1.7.1 General

1.7.1.1 Discipline at all NLSA sanctioned events will be dealt with under the NLSA Disciplinary Code which is available online at www.nlsa.ca.

### 1.8 AFFILIATION

1.8.1 All players, team staff and officials on the Mega roster must be registered in the NLSA database at least five business days before start of the competition.
1.8.2 Players and team staff added to any team after the team's initial registration must be registered in the NLSA database at least 24 hours prior to the player's first game.

### 2.0 ELIGIBILITY <br> 2.1 Teams

2.1.1 All teams must register with their recognized Club in order to affiliate with the NLSA.
2.1.2 Only teams affiliated with and in good standing with their Club will be eligible to participate in any competition under the jurisdiction of the NLSA.
2.1.3 Teams must be prepared to play games against teams in their own region prior to the official start of the tournament.
2.1.4 Teams should arrive on schedule for all games and be prepared to play. The NLSA may take disciplinary action against any team failing to meet its responsibility.
2.1.5 Teams are expected to conduct themselves in an appropriate manner both on and off the field. Failure to do so may result in disciplinary action by the NLSA.
2.1.6 If a club team represents a region in a Provincial League, that club team is not eligible to participate in any Mega tournament unless invited by the Competition Committee.
2.1.7 Provincial Competitions may be held for each of the following categories:
2.1.7.1 Intermediate Men - Open Age
2.1.7.2 Intermediate Women - Open Age
2.1.7.3 Masters Men -Over 35 - All players must be thirty-five (35) and over years of age prior to January 1 of the current year.
2.1.7.4 Masters Women - Over 30 - All players must be thirty (30) and over years of age prior to January 1 of the current year.
2.1.7.5 U18 - All players must be under 18 years of age before January 1 of the current year.
2.1.7.6 U15-All players must be under 15 years of age before January 1 of the current year.
2.1.7.7 U13 - All players must be under 13 years of age before January 1 of the current year.
2.1.7.8 Youth teams will not be permitted entry in any Senior Mega Tournament unless there is no tournament at the Youth level in their age group and NLSA approval has been given.

### 2.2 Players

2.2.1 Only players registered with a Regional Association or club shall be eligible to compete in any Provincial Mega tournament.
2.2.2 A player may not register or play for more than one team in the same tournament.
2.2.3 The final date for registration is August 31 of the current year.
2.2.4 A youth player who registers first with a senior team will not be eligible to play for a youth team.
2.2.5 A youth player who has played for a senior club team during the regular season is cup-tied to that club for any senior competition unless $s /$ he has received an official transfer.
2.2.6 A youth player may not play in more than one (1) Provincial Youth Competitions in the current year unless an exemption has been given. (See exemptions)
2.2.7 No person may participate as an official and a player in the same Provincial Mega competition.

### 2.3 Coaching Staff

2.3.1 Minimum Coaching qualifications:

The NLSA would recommend the following

2.3.2 All staff persons listed on a team roster going to an NLSA Mega Tournament must be Enhanced Police Information Check (E-PIC) cleared (valid for 12 months) and have completed Respect in Sport and Safe Sport (available on the NLSA website www.nlsa.ca
2.3.3 Enhanced Police Information Check (E-PIC) clearance, Respect in Sport for Activity Leaders and Safe Sport training for all club teams are the responsibility of the club; however, a club or regional representative must verify the names of the team staff who meet the criteria.
2.3.4 A team's staff should consist of a minimum coach, an assistant coach and a manager, one of who must be the same gender as the players and must be on the bench for entire games. Each team entering a Mega tournament must have a minimum of two (2) staff.
2.3.5 For the requirement that a team official be the same gender as the team, for

Intermediate and Youth this cannot be a player with dual roles on the team. For Masters Division the gender requirement may be filled by a player/coach.

### 2.4 Exemptions

2.4.1 A youth or senior player playing soccer with a given club or region may play Challenge Cup or Jubilee Trophy with a different club or region only when the higher level of competition is not available in his or her own club and the approval of the Competitions Committee has been given.
2.4.2 Provincial team players who are not playing in the Premier Youth League (PYL) may participate in a Mega tournament.
2.4.3 Clubs must apply to the Chair of the Competition Committee, who will forward the request to the technical staff for evaluation and approval, to use any PYL , Provincial team or overage (up to 3 permitted) player(s) in a Mega tournament . In evaluating this request the technical staff will consider the following:
a) The number of players requested.
b) The residence of the players requested.
c) The total number of age eligible players registered with the club and/or region.
d) The history of the player playing with the club in the current season.
$\begin{array}{ll}\text { 2.4.4 } & \text { Any team registering for a Provincial Intermediate Mega tournament may } \\ \text { register a maximum of three (3) Intermediate players from Intermediate teams } \\ \text { not participating in the tournament. }\end{array}$
2.4.5 No player playing or called up to the Challenge Cup or Jubilee Trophy League will be eligible to play in any Youth Mega Tournament unless the youth team has been invited to play in the Mega.
2.4.6 A player may play in more than one Provincial tournament if the player has been approved by the Competition Committee through the Chair of the Competition Committee as an emergency "call-up" as defined by the specified guidelines. Preference will be given to players from that region who have not or will not participate in a provincial tournament in the current year. Call-ups must meet the eligibility requirements specified in the NLSA Policy Manual.
2.4.7 Guest players (players from a different club) are permitted to play with a team in a Mega Tournament under specific circumstances. Teams without sufficient numbers are permitted to add guest players to give them enough to compete in a tournament that they would otherwise not be able to enter, or have to withdraw from, because of low numbers. The specific guidelines for this concept can be found in the NLSA Policy Manual.

This is not meant to replace "call-ups" who are players from the same region as the team they are joining.

## 3 ADMINISTRATION

### 3.1 Documentation

3.1.1 Teams in Mega tournaments must have their online Credential Form and full tournament registration fee into the NLSA office 3 weeks before the start of the tournament. Provided the schedule allows for the addition of an extra team, late entries may be accepted no less than 17 days before the start of the tournament and only when accompanied by a late registration fee of $\$ 100.00$. Acceptance is at the discretion of the Competitions Committee.
3.1.2 No changes will be permitted to the online Team Credential Form within seventy-two hours of the scheduled start of the Provincial Tournament without the permission of the appropriate Chair of the Competitions Committee.
3.1.3 If a club/region makes changes to a team's roster or coaching staff the club/region is responsible to update the online credential form
3.1.4 Regional Directors are responsible for ensuring that any team representing his/her Region in Provincial Competition is properly registered with the NLSA..
3.1.5 If necessary, all teams entering Mega Tournaments must be prepared to commence play Thursday evening

### 3.2 Travel and Hotels

3.2.1 All teams must make their own arrangements for travel and accommodations.

### 3.3 Attendance at Meetings

3.3.1 All teams must have a representative at the pre-tournament meeting convened by the Manager of Soccer Operations. Failure to do so will result in a fine of $\$ 200.00$. In the case of special circumstances, exemptions may apply, provided approval has been given prior to the meeting.
3.3.2 The teams have the option to conduct pre-tournament meetings through virtual means before the tournament, prior to the commencement of the event, or as a meet-and-greet upon their arrival. The coaches of the teams will receive information regarding the meeting's time and location.

### 3.4 Awards

3.4.1 The NLSA will ensure that a championship trophy, plaques and medals are provided for each competition and will be presented at the completion of each tournament.

## 4 TECHNICAL

### 4.1 Administration

4.1.1 Only team staff and players listed on the game sheet and registered to the team in the NLSA database shall be permitted to sit on the players' bench and play in any game for the team.
4.1.2 Any team that submits an incomplete game sheet (not listing eligible players who are on the Team Credential Form) will be subject to disciplinary sanctions. See fines.
4.1.3 Maximum number of players registered per team

4.1.4 In 11 vs 11 games, teams must have a minimum of thirteen (13) players to register for a tournament, seven (7) players to start a game and seven (7) players to continue a game.

### 4.2 Duration of Play

4.2.1 Duration of Play for regular round robin games

### 4.2.2 Duration of Mega Championship Games

4.2.3 In all Mega Championship Games, when the score is tied at the end of regulation time, the winner shall be decided by the taking of kicks from the penalty mark, in accordance with FIFA Laws of the Game.

### 4.3 Team Uniforms

4.3.1 When the colours of the competing teams are similar, home teams shall use alternate colours. Hosts should have a set of jerseys or pinnies available in case there is a conflict.
4.3.2 Goalkeepers must wear colours (jerseys and socks) that plainly distinguish them from all other players and game officials.
4.3.3 No purple team uniforms can be used.
4.3.4 All players, including called up players, must wear uniquely numbered uniforms.
4.3.5 All jerseys must be clearly numbered as per FIFA Rules. The number on the player's jersey must correspond to the number listed with the player's name on the game sheet.
4.3.6 Players are not permitted to wear anything that is dangerous to themselves or other players. NO jewelry: that includes rings, bracelets (except medic alert bracelets that must be either made of Velcro or similar soft material or covered with a sweatband), earrings, necklaces, other visible body piercing, etc. The practice of taping jewelry is not acceptable.
4.3.7 The wearing of shin guards is mandatory for all players in all competitions governed by the NLSA.
4.3.8 Appropriate soccer socks, which completely cover the shin guards, must be worn.
4.3.9 All shirts must have sleeves.
4.3.10 At the referee's discretion, goalkeepers are permitted to wear baseball caps if the sun is directly in the keeper's eyes.
4.3.11 No player will be permitted to play while wearing a hard, plastic or fiberglass cast. Soft casts (gel or sponge) will be permitted for senior players provided the cast is properly and adequately padded and referee approval is obtained.
4.3.12 In all provincial tournaments, all splints, braces, etc. must be checked by the senior official in attendance. Canada Soccer Guidelines will be used in determining the acceptance or rejection of the equipment. It is the responsibility of the coach to ensure that all equipment is presented for inspection.

### 4.4 Substitutions

4.4.1 All provincial tournaments shall have substitutions at the referee's discretion as listed in the chart below. Players who are substituted out are permitted to re-enter.

4.4.2 No substitutions will be allowed for a player who has been ordered from the field for misconduct.

### 4.5 Discipline

4.5.1 All Discipline will be governed by the NLSA Disciplinary Code available online at www.nlsa.ca

### 4.6 Format

4.6.1 Teams must indicate on their online registration forms the level of competition they wish to enter. When applicable, championships will be held at the Mega "A", Mega "B", Mega "C", etc. levels.
4.6.2 Teams shall be seeded based on the previous year's results within the level of competition noted above where applicable.
4.6.3 Clubs that did not participate in the previous year's Provincial Tournament will be placed as low seeds as determined by the Chair of the Competitions Committee.
4.6.4 Rankings made for the Mega tournament by the Chair of the Competitions

Committee are final and binding .
4.6.5 The Manager of Soccer Operations will draw up the schedule in consultation with the host convenor and will ensure that each team has the equivalent of one game rest period between the end of one game and the start of another.

### 4.7 Tie Breaking Procedure

4.7.1 In tournaments or parts of a tournament organized on a knock-out basis, if a game is tied at the end of regulation time the game shall be decided by the taking of kicks from the penalty mark in accordance with FIFA regulations.
4.7.2 In any three (3) team round robin, whether part or whole of the competition, the third game shall be played to a decision if the team NOT playing has zero points, has been suspended or has withdrawn. If the game is tied at the end of regulation time the game will be decided by the taking of kicks from the penalty mark in accordance with FIFA regulations. In all other games in round robin play ties will stand at the end of regulation time.
4.7.3 Three points shall be awarded for a win and one point for a tie.
4.7.4 The following criteria shall be used to determine final standings:
4.7.4.1 Most points in all group matches.
4.7.4.2 If two (2) teams are tied in points in all group matches:
a) Greater number of points in matches between the teams concerned (head to head competition)
b) Greater goal difference in all group matches;
c) Greater number of goals scored in all group matches.
d) Kicks from the penalty mark as per the Laws of the Game, at a time and place decided by the appropriate Vice President.
4.7.4.3 Where kicks from the penalty mark are used for tie breaking, players under suspension are not eligible to participate; however, this does not constitute the serving of any disciplinary suspension already awarded.
4.7.4.4 If three (3) or more teams are tied in points in all group matches the following are the only criteria to break the tie:
a) Greater goal difference in matches between the teams concerned (head to head competition)
b) Greater number of goals scored in all matches between the teams concerned.
c) Greater goal difference in all group matches.
d) Greater number of goals scored in all group matches.
e) Drawing of lots to determine ranking at a time and place decided by the appropriate Chair of the Competitions Committee.
4.7.5 In each situation above, the decision of the appropriate Chair of the Competitions Committee is final and binding.
