Request from Holly Bond– can the free agent list be cleared prior to the season so teams know players are actually available

Question: can teams be notified when players are added. MJ – Angela normally questions the players on their skill level and contacts the teams in the appropriate level. MJ to check with Angela

Question: can lowest level of play choices be changed to maybe years of experience?

Concerns by teams about whether or not the smaller pools experienced in Rec A/B will occur again this year.

Motion: brought by Holly Bond (Capitals); Erin Robinson (Hurricanes) seconded make Super Bowl Sunday a regular game date; 11 in favour/18 opposed – motion not carried and

will remain a league blackout date. Teams who do not want to play games that date must explicitly request that as a team blackout date.

Mike: appeals and team rosters

- Gamesheet is like a legal document; example last year one team had to forfeit a playoff game due to an illegal player. Make sure gamesheet reflects who is really at the game – cross off those who are not and make sure if they are playing they are not crossed off
- Suspensions: 24 hour on the clock from the time the email of suspension goes out for teams to appeal the decision. Appeals cost money and while appeal is ongoing the player in question cannot play.

Suggestion from Jess: provide teams a sample of an appropriately filled out gamesheet to help train timekeepers

Is there anyway to change default printer settings on gamesheet? (To address small printed font on some gamesheets)

Question about the clarification around road conditions. There are rules documented around games during inclement conditions. Example from last season Westlock players involved in car accident when weather conditions were extreme
