- League Ice Costs will be averaged & notify teams at Sept AGM, last year it was \$370.

- Pool Ice to accommodate scheduling when we can

Scheduling for the future:

We are all aware that there have been major issues with scheduling over the last number of years. Scheduling issues have been noted however automated schedule system offered by Canlan or Carha do not work for our schedules because we have too many variables. If Nafha owned the ice, like these other groups, we could use one facility then the scheduling programs would work however we do not. We have tested them and they are not compatible with our ice.

We can't keep a person in the position as it's very difficult.

Dar made a suggestion to have VPs and team reps meet the first week of September to devise a schedule that works for their division. Teams must come with their ice slot and black out dates.

- -Schedule should be from beginning to end of season with no re-tiering in the middle. Teams should select the tier they are wanting to play in for the year. Teams need to declare by August 1 as well with the ice.

- 5) Bingo report- some teams left bingos, there are bingos for players to use. Parkland bingo runs a bingo school to assist with understanding, make sure papers are sent in, binges are normally once a month. In spruce grove, 445 to 930pm is the slot time.
