- 3. SPRING AGM MAY 2, 7:30 VIA ZOOM -
- 4. VP REPORTS
 - DIV 1 Good year, no complaints. Splitting the stats was a bump for VP's. Game sheets need to be clear.
 - DIV 2 Pretty well, Blackhawks don't know if they will be back in the fall
 - DIV 3 absent
 - DIV 4 Season wasn't too bad, despite some last minute cancellations. Address issues with teams being ready to start the game on time. Timesheet were not completed and didn't have the real players.
