### **Arena 2020 COVID-19 Agreement with Terms and Conditions for**

#### **Indoor Facility Use for All User Groups**

---

Please read this entire document provided by the Stavely & District Agricultural Society, (Stavely Ag Society). Complete the attached participation contact information, sign the waiver and return to the Stavely & District Agricultural Society.

#### **All Users are responsible for ensuring that their members observe regulations as follows:**

1. All users must follow Province of Alberta and Alberta Health Services guidance on indoor/outdoor activities related to COVID 19, including:
  - a. Physical distancing must be followed. Ensure participants are not within 2 meters, (6 feet) of each other. Organizations, groups and those hosting indoor recreation activities should refer to [alberta.ca/biz](http://alberta.ca/biz) Guidance for Sport, Physical Activity and Recreation for supports to help non-profits and businesses open safely.
  - b. Each user group will be required to follow their provincial or national sport governing bodies guidelines related to COVID-19
2. Coaches and instructors are to reinforce the message of social distance guidelines. All user groups will be responsible for asking the COVID-19 Screening questions to all participants attending and assuring with the Stavely & District Agricultural Society that this will be completed each time your group rents the facilities.
3. All users will be responsible for supplying their own PPE including masks and gloves if they choose to use them. The Stavely Ag Society will supply hand sanitizer in designated areas.
4. Please self assess according to AHS guidelines before entering the building.
5. Hands **must** be sanitized at front door upon entering facilities.
6. All Users must follow guidelines regarding entrances and exits.
7. Masks are not mandatory at this time but are recommended.
8. Dressing rooms can accommodate a **maximum of 15** players/users and must maintain physical distancing.
9. All participants must arrive no more than 30 minutes prior to their booking and they must leave within 30 minutes after ice time has completed.
10. Showers will not be available until further notice.
11. The maximum number of individuals in a group inside the facility is 100 people as per provincial orders.
12. Teams are responsible for sanitizing their own equipment, (pucks, pylons etc.)
13. Although your ice times are confirmed, please be aware that time adjustments could still occur as the arena begins to open.
14. COVID-19 Cleaning protocols over and above regular cleaning will be spraying the dressing rooms with a cleaning product & sanitizer, daily wipe down of high traffic/touched areas.
15. Restrictions in and out of certain areas will be in place as well as certain areas and facilities will be closed off.
16. This contract can be altered and/or amended at any time by the Stavely Ag Society as they see fit with the changing COVID-19 situation.
17. It is the responsibility of the User Group to track the names and dates of individuals present being players, coaches, referees or spectators and will be able to provide upon request.
