- I shall comply with all "Rules of Conduct" and report to the team's training camps in compliance with the team's pre-season conditioning program.
- I acknowledge that a player may be released from the Player Agreement under the following conditions:
  - o failure to attend school
  - use of tobacco products/alcohol/cannabis/illegal drugs
  - o consistently violating team curfews
  - disrespectful behavior both on/off ice
  - failure to comply with other aspects of the team's "Rules of Conduct"
- I commit to pay annual registration fees as stipulated by the Team / Host MHA.
