Open Forum

Q- Dennis Inglis

Team Cash calls, concern paying companies a head of services, asked to see the service agreement with Village Sports.

A- Association changed the invoices for the 2 daytime teams for the academic and video piece to reflect 50% now and 50% in January for the 2nd semester reducing the overall invoice and need for extra cash call. OOAA is forming a committee to review what other associations do for cash calls and team payments.

The heater is not working in the storage unit. Who is responsible for its maintenance?

A- The company that built the storage units maintains them. If something is not working then the teams must let the division director know so it can be addressed

Asked Dan to consider stepping down until the ITP investigation has been completed since he was at the helm in 2021.

Why does U18AA have to colunteer in the Circle K? What are we getting out of it?

A- OOAA is a host team and is required to supply 70 volunteers in different roles throughout the tournament. It been a long standing tradition that the male teams from Okotoks from U13AA up help fill these spots. The association does not get paid to supply the volunteers.

Q-Lisa Rivett

Is OOAA going to make any changes in the hiring process of coaches due to the negative impact that some of the female hires have had on the players?

A- Yes, the coach Director will be reviewing the process to learn how we can improve and what did we learn from some of the past hires.

Why has OOAA not reached out to the 21 female families to find out why they have left the association? OOAA did have some great female assistant coaches that were training to be head coaches.

A- Orinda Suggested Amy Snyder sit in on the coach interview process to ask questions that surround the mental health side of the coach

Q- Danny Crook

Does OOAA do coach reviews throughout the season?

A- Yes, approximately 2 weeks after the IGM the parents will receive a mid season review survey. The Coach Director will review these surveys and meet with the coaches.

Amy Snyder- The association needs to be working with the players to empower them to speak up without fear of repercussions. She is an advocate for the players. She is working with outside agencies to develop a plan that works that she will present to the board.

Q- Danny Crooks/Ryan Goulard

Can the Executive come observe practices and games unannounced to see how the coaches are speaking to the players/how the overall game is being run etc.

A- Michelle Barratt often attends many games to observe and take pictures. She does not have a player in the association can watch un detected

General Discussion/Statements

What are ways for players and parents to bring forward complaints without fear of repercussion. Many ideas thrown out. – Confidential form. Whistleblower, selecting the correct coaches, changing the culture of fear. Board needs to advocate for the players more than the coaches. Focus on being better people than winning.

Rob Ellis asked anyone to reach out to him. He does not have a player in the association. Kari Meyer will add a feedback tab on the website.

The board will discuss ideas to improve in this area at a future board meeting.

- 1- Geoff Stewart has concerns over the longevity of the organization due to lack of volunteers and the turn over that will occur in the next 1-2 years. OOAA and OMHA need to work together to help fill these roles
- 2- Gabe Amyotte- Association needs full transparency and the hire of coaches cannot be "friends" of the board. Action needs to occur from the board when issues arise with players/coaches.
- 3- Jeremy Gough- The statement that came out from OOAA indicated that OMHA knew about the letter from the parents on March 10th. When in fact they learned about this letter last week. An email needs to be sent out with clarification.

OOAA and OMHA have 2 separate sets of policy's and procedures. These needs to be aligned.

A- A few years a go OOAA bylaws were reworked to mirror OMHAs. The policy's and procedures take time since both associations are volunteer based.
