    - Responsible for any ice submissions to the OWHL-Eastern league that may be necessary league, playoff, and playdown games.
    - Shall provide a monthly report at each executive meeting.
    - Will be the association's contact with the Referee Assignor and arrange for referees for each team's home games.

## **OVDGHA PRESIDENT REPORT 2021/2022 Season**

The Ottawa Valley District Girls Hockey Association competed with six teams during the 2021/22 Hockey Season. The following teams competed in the Ontario Women's Hockey League – Eastern Division; U13 Thunder House, U13 Thunder Competitive B, U18 Thunder House #1, U18 Thunder House #2, U18 Thunder Competitive C, and U18 Thunder Competitive A.

Our all girl's hockey association attracts players from the entire Ottawa Valley ranging from Deep River to Barry's Bay to Arnprior. We have dedicated families and players who have to travel great distances in order for their daughters to practice, play, and compete in the game they love. It is our opinion that the experiences, skill development, competition, and comradery that our players receive is worth the travel time and cost. Each of our teams practiced and played their home games in Pembroke, Petawawa, and Whitewater arenas and away games were in Ottawa and area. Our house team player registration fees ranged from \$450 to \$600 and our competitive team player registration fees ranged from \$1000 to \$1250. These fees included all practice and game ice times, tournament registration fees, referee fees, team photos, and a team set of jerseys to use. The player registration fees were reduced accordingly after a month-long pause in January for covid.

Several of our teams had outstanding seasons achieving many awards throughout. Our U13 Competitive B Thunder team were finalists in the Clarington and Barrie tournaments. In their inaugural year they had a tremendous amount of success finishing 3rd overall in the OWHL – Eastern League, second in the OWHL-Eastern Playoffs and narrowly missed qualifying for the OWHA Provincial Championships. Our U18 Thunder House #1 team finished 1st overall in the OWHL-Eastern League and were semifinalists in the OWHL-Eastern playoffs.

Our U18 Thunder Competitive C team finished 2nd overall in the OWHL-Eastern League and were 4th overall in the OWHA Provincial Championships.

Finally, our U18 Thunder Competitive A team finished 2nd overall in the OWHL-Eastern League, were the OWHL-Eastern Playoff Champions, and finished 4th overall at the OWHA Provincial Championships. We would like to wish all of our graduating minor hockey players all the best in their future hockey and school endeavours. Congratulations to Shaye Close, Kaitlyn Gage, Ella Grad, Paityn Leach, Morgan McEachen, Emma McGrath, Emma Misener, Kiana Patrick, Isobel Perrault-Sanders, Jamie Ring, Lou Russell, Julia Swant, and Alexis Waito.

## **Equipment**
