Women's U18 requires two votes. Please read the entire email before casting a vote.

There are 3 Tier 1 teams and 4 Tier 2 teams.

T1 - Adanacs, NW, Ridge

T2 - Adanacs, Langley, Mission, Ridge

Voting #1: SCHEDULING

**Option 1: Blended schedule?**

- One team would have a bye
- The crossover game between T1 / T2 would be considered an exhibition game

**Option 2: Separate schedules?**

- Each week, the home team would rotate, and that home team would play a back to back; while the other 2 visiting teams would play 1 away game a week.
- Will requires a PCFLL policy amendment at the upcoming League meeting: reduce the game break from 1-hour to 30-min. Once it gets wet and cold, players, coaches, officials and parents will not want to wait a full hour before the next game starts.
- No change to T2 since there are 4 teams.

Here are the results as voted by association members:

Voting #1: SCHEDULING

By Majority Vote = **Option 2: Separate Schedules**

- Each week, the home team would rotate, and that home team would play a back to back; while the other 2 visiting teams would play 1 away game a week.
- Will requires a PCFLL policy amendment at the upcoming League meeting: reduce the game break from 1-hour to 30-min. Once it gets wet and cold, players, coaches, officials and parents will not want to wait a full hour before the next game starts.
- No change to T2 since there are 4 teams.

*\*Note: PCFLL will monitor game results and may consider shuffling teams (ie. across tiers, etc.) in order to promote balanced competition.*

By Unanimous Vote = **Option 1: All U18 Games in One Location**

- Officials can do multiple games
  - Only a small handful who can do u18
  - Mentorship and evaluation is easier with one location
- Simplifies shot clocks for u18 since it's one location

- Could make a case for zoning next year

*\*Note: The Tier 1s and 2s will play their separate schedules, but both Tiers will play in their respective locations. What does this mean:*

- *Tier 1 = 3 teams.*
  - *Each team will host a **home** game every 3 week rotation. The home team will play two games per day, with a minimum 30-min\* break in between games (\*length of break is pending next league meeting vote).*
- *Tier 2 = 4 teams.*
  - *Each team will host a **home** game every 4 week rotation. With 4 teams, there will be no back-to-back games by any Tier 2 team. Each team will play one game per day.*
