Treasurer Report

The accountant Sherry Colney from Limelight Accounting shared the financial report for the fiscal year end of July 31, 2020. Of note:

- 2020 recorded a loss due to a cancelled season
- Still have a surplus revenue for 2020, mainly consisting of sponsorships from 2020 and members who chose to leave registration fees in trust with PPLA for future programming.
- GELC paid for club's fees to ALA as ALA was not providing refunds.

Presidents Report

- 2020 season cancelled
- Were on pace to register record amount of participants
- Jr. summer drop-in program held in Devon was successful; 20+ players attended regularly
- 4 athletes from Parkland Posse have progressed on to collegiate programs in US in 2020
- Partnered with Chaos Field lacrosse in the summer, feedback was positive
- Partnered with GELC for winter 4x4 program, initial feedback is exceptional
- 2021 Priorities for Board of Directors:

- Outlook still uncertain given COVID-19 ensure communication is clear to membership prior to registration
- Continue to grow sport through recruitment
- Improve communication to members via newsletter
- Player retention will be key to our program's livlihood
- Continue to find creative ways to offset costs of registration
- Build on the success of the inaugural JR B season
- Assess what type of winter program we will run January-March 2021
