

4.3 VP/President: insurance increased from last year; players skating on sanctioned ice must have sanctioned insurance; drop date Sept. 1/2023; U16 AA official league; took leave for one season; coaches not chosen; board needs to decide if we are "in" for 23/24 season; tryouts have 21 registered as of now; 2 are goalies; motion to accept U16AA for 23/24 season; Damon, 2nd Troy, Carried.

One family requested to be released from PRMHA, released to Grimshaw, motion made: Troy 2nd Damon. Carried.

Camp: looking good; jerseys ordered; numbers are sitting good; total camp cost approx. \$30,000; potential to bring in revenue; older skater that help with camp will have camp paid for; any parent volunteers and assistants may potentially have fundraising deposit paid for; Goalie camp runs around \$9000; will run at a potential loss; power skating on weekend of Aug 26,27; U9, U11, U13, U15, U18 groups; \$50 per skater, 20 per group; approval to run power skating weekend; motion made Damon, 2nd Tianna.

paid for clinics; clinics to be held earlier in season; as early as Sept. 2023. 5.0 **New Business & Agenda Additions** 5.1 Community sponsorship; will make an advertisement that community businesses can contact PRMHA; put in a request for certain teams to help; labour in exchange for sponsorship. 5.2 Nampa AG Society: Board member rep; waiting to hear on representative and number of meetings that are needed to attend; Steve is rep as of now; if he is unable to go other board members will attend in his place; meeting 2nd Thursday of every month. 5.3 Concession: changed for this season; waiting for applications; potential to be open for camp; if not open will look into food trucks. 5.4 Tryouts: Volunteers for tryout process; on ice, front desk, jersey dispersal; google doc will be sent out so all of association and surrounding can volunteer time to assist. Formalize tryout structure to be more of a game format if numbers are conducive; if not fall back onto battle drills; small area games; 3 on 3; limit time to one hour; will be game situational tryouts.
