6.0 6.1 Presidents Update

- Safety Position will be required for PRMHA for the 2020-21 season.
- Trevor & Erin attended a meeting with Brian Wollis and Meghan MacLeod about the procedures of opening the arena during COVID-19. There will only be one arena attendant due to 20 percent cutbacks for the upcoming season. Hockey players will have to arrive to arena fully dressed (except goalies), no hockey bags allowed in facility, no spectators, showers will be off, only 9 people can be in dressing room, female dressing rooms 3, social distancing on the bench and temperature/form filled out by everyone. 100 people allowed in the entire facility. No exclusive ice until September 4, 2020, no summer hockey camps. No dryland will be allowed unless we can rent the multipurpose room or court. Requesting to have pickup and drop off at opposite sides of rink entrances. Ice rates will stay the same. Trevor Lamabe will be requesting a meeting with TOPR Council.
- AB Hockey will not be issuing any permits for tournaments until January 2021. If anyone from hockey tests positive for COVID-19 the facility is closed for 14 days. Cohort groups of 50 will be used. AB Hockey will be working with the current health and safety standards in AB. The reopening of arenas is phase three.
- NAHL still plans to have 6.5 games a month, there will be no catch up games if league doesn't start till later in season.
- APHL no work on anything yet.
- Request from Nampa Minor Hockey to support them in endeavor to have female ATOMS team. They
 have applied to APHL, league doesn't usually let associations in with one team and for possibly one
 season. One option is to come under PRMHA if that decision is made. They would like advertise on
 our social media and website. This will impact PRMHA has we have approximately 6 atom girls.
 Motion to support NMH in posting on website, social media to recruit female players. If APHL turns
 NMH down, they can come under PRMHA, moved by Kelly Flynn and seconded by Kirk Lowe.
