



## **RULES & REGULATIONS**

### **Peg City Youth Basketball Showcase Weekend**

#### **QUICK REFERENCE GUIDE FOR REFEREES**

- 5 MINUTE MINIMUM WARM
- 10 MINUTE QUARTERS \*STOP TIME\*
- 5 MINUTE HALFTIME
- 5 MINUTE OVERTIME
- 2 FULL TIME OUTS PER HALF; NO CARRY OVER
- 1 TIMEOUT FOR OVERTIME
- 24 SECOND SHOTCLOCK and 8 SECOND BACKCOURT (17U, 16U)
- 30 SECOND SHOTCLOCK and 10 SECOND BACKCOURT (15U, 14U)
- ALL DEFENSES ALLOWED – ZONE AND MAN TO MAN
- INSIDE 3 POINT LINE FOR ALL DIVISIONS

#### **GENERAL RULES**

All games will be played under the current FIBA rule system with the following exceptions:

1. All games will consist of 10 minute quarters, 5 minute overtime if required (no double overtime).
2. The 24 second shot clock for 17U and 16U divisions and 30 second shot clock for ages 15U and under, which will be kept by the officials.
3. Running Time Rule: If there is a team leading by more than 20 points in the 4th quarter, the clock will run until the deficit becomes less than 20 points.
4. The official game size basketball for boys is 29.5 and for girls is 28.5.
5. Teams are to provide their own warm-up balls for the games, PCYBL will provide game balls.
6. Each team will be given a minimum of 5 minutes to warm up and 5 minutes for halftime.
7. Each team is responsible for cleaning the bench area after games.

## **PLAYERS**

Players may play for a maximum of 2 different age/grade divisions. A player may play up an age/grade division but it must be with a team from the same Club.

Players may be added to a team registration after the roster deadline has passed.

To be eligible for the Championship Tournament a player must be on the originally submitted registration or must have played in 4 regular season games. Teams are not permitted to drop any player(s) from the team registration form to make space for player additions once the team roster has been submitted to Peg City.

*\*\*Each athlete is permitted to play on ONE CLUB per Showcase season. However, an exception is granted for athletes wishing to participate on a cultural or heritage-based team in addition to their club team. This is allowed under the following conditions:*

- *The athlete must play in separate divisions or tiers for each team.*
- *The cultural or heritage-based team must be actively training together to prepare for a cultural or heritage-based competition.*
- *Once an athlete has played in a game for a cultural or heritage-based team, they are required to stay with that team for the remainder of the season in that specific division/tier.*
- *Similarly, once an athlete has played in a game for their club team, they must remain with that team for the rest of the season within that specific division/tier.*

*Failure to comply with these regulations will result in the athlete being removed from competition for the remainder of the Showcase season and will be subject to additional provisions as decided by the Showcase administration.*

## **ZERO TOLERANCE**

There is a zero tolerance policy in effect for the treatment of Peg City staff (Referees, Scorekeepers, Statisticians, etc.). If it is found that an individual(s) has been abusive (verbally or physically), he/she will be asked to leave the venue and will not be permitted to return for that session as well as all other Peg City activities and events.

## **FIGHTING & EJECTIONS**

(Coaches and Players) The first time an individual participates in a fight/ inappropriate incident or gets ejected (2 technical fouls) in a game during the Peg City season, the individual shall be suspended from participating in the team's next Peg City regular season and/or playoff game.

The second time an individual participates in a fight/ inappropriate incident or gets ejected (2 technical fouls) in a game during the PCYBL season, the individual shall be suspended from participating in the team's next TWO Peg City regular season and/or playoff game.

The third time an individual participates in a fight/ inappropriate incident or gets ejected (2 technical fouls) in a game during the Peg City season, that individual shall be suspended for the remainder of the Peg City regular season and/or playoffs and may/ may not be able to participate in future Peg City seasons.

## **ELIGIBILITY AND PROTESTS**

All protests must be submitted in writing to the Peg City administration. Teams being protested (based on concerns over the eligibility of players) must produce a legal birth certificate. A final decision will be made by the Peg City administration and will not be subject to any further discussion. Proof of eligibility (birth certificate or passport) must be produced in the event of such a protest.
