### **New Business**

- Lyle Thomas here to discuss, questions that were posted on Facebook-
  - 1<sup>st</sup> question was regarding upgrades to the arena and the last 5 years were reviewed we imported the lighting in parking lot, new score clock, new signage, led message board, interior and exterior painting, new brine pump, flooring upstairs and downstairs, drywall and paint, in ice surface lights, mezzanine bathroom dividers, new sound system, sound booth
  - Why does the roof leak- been ongoing for 17 plus years, there has been engineers brought in basically it's too flat.....bad design for its purpose, it contracts and expands it's not meant to hold snow, only leaks when heavy rain or lots of snow and tournaments, causes approx. 6" of water- the building now has professional grad heat traces, we experimented last year on one side, it was successful and now have installed on both sides for this season, hoping for success, also attempting to seal seam
  - Putting a money into a replacement reserve approx. \$180,000, will be changing out the chiller it cost
     \$130,000, that will take president over the roof repair.
  - Why is the upkeep not happening- the building is 44 years old- maintenance is ongoing and the town needs to update community better
  - We need a new floor- off season is on May, June and July. Hold ice to 2<sup>nd</sup> or 3<sup>rd</sup> week of April. They try to accommodate all request. They are working on lacrosse for May and June.
  - There is a crack in the floor at center ice that was there since day 1, the steel cable used to the hold the center post together, when 1<sup>st</sup> ice went in the metal cable caused the crack.
  - o Comment made would new pool fall into same disrepair??- After 44 years this will not shiny new either
  - Concession-town took it over-1<sup>st</sup> the concession is the towns (PDMHA- need to look into RDOS- believe that PDMHA believes that it was always the theirs, Town stated claiming ownership only since last CAO), town believes that town contracts to PDMHA 1996- 2005, profit is approx. \$8500 per year.
  - Minor hockey subcontracted to minor hockey 2005- 2018. (town could not provide documented proof)
     Past parents now grandparents have stated otherwise, since originally the arena was operated by the
     RDOS and not the town that the concession was always Minor hockey's since the 1970's)
  - o No answer given to when the RDOS gave arena to town
  - Dan Lankin had a conversation with Lyle, risk and reward, minor hockey would have been liable for any illness. (Lyle contradicted himself stating the Town carries the liability that is why they "took it back", but then RFP- states that the liability insurance is at the cost to the contractor?!?!
  - Most towns are carry the contracts etc. Due to contract coming due, it was arranged to channel money back to the PMHA, letter to Sue stating that it would be a contract direct verse a sub-contract(see attached)
  - o There was a funding formula, 50% to minor hockey, 40% to Posse and 10% to Figure skater.
