The top 2/3 of the roster will be locked in from evaluations and the bottom 1/3 will be coaches picks (these picks come from the top half of the remaining players and no allowance to go off board for assistant coach purposes, friends, family etc.).

- Ensure that the evaluation forms are not distributed beyond independent evaluators and coaches (not to all parents, etc.)
- Would SAHA provide more engaged independent evaluators?
- Ensuring coaches picks are a collaborative effort between the two head coaches and the division director.
