

COVID-19 Related Conditions of Use Guidelines

Gary W. Harris Canada Games Centre Ice Arena Effective August 24, 2020

In addition to the facility's regular *Conditions of Use Guidelines*, the following guidelines will be in effect until further notice:

RDC COVID-19 RULES

- 1. Stay at home if you are feeling ill**
- 2. Complete the COVID-19 Contact Tracing and Alberta Daily Check list using the SAFE RDC App**
- 3. Face coverings must be worn at Red Deer College**
 - In all common areas, such as hallways and lounges
 - Whenever a two-metre physical distance cannot be maintained
 - By everyone over two years old
- 4. Maintain a two-metre physical distance from others whenever possible**
- 5. Wash/sanitize your hands often**

- All participants and spectators are expected to be registered individually or by the Renter's Coordinator for each daily session. The SAFE RDC App is a free tool has been developed to support activity organizers and facility operators in reducing the risk of transmission of COVID-19 among attendees. The tool is meant to be used to assist with assessing attendees who may be symptomatic, or who may have been exposed to someone who is ill or has confirmed COVID-19.
 - a. You can download the SAFE RDC App to an Apple Device by typing in SAFERDC in the app store
 - b. To download on all other devices type in RDCSAFE
 - c. Complete the Daily RDC Check-In by opening the SAFE RDC App and select the COVID-19 Contact Tracing and AB Heath Daily Checklist
 - d. Follow the prompts to enter your contact information and answer the Daily Health Check questions
 - e. If you answer "YES" to any of the questions you are not permitted to attend any activity at an RDC Facility, you must self-isolate and it's recommended that you complete COVID-19 testing.
- Participants may arrive no more than 10 minutes prior to booking and must leave immediately following the booking.
- Arena Entrance Only: Gord Bamford Foundation Skate Lounge.
- Arena Exit Only: West Players Bench Hallway (South).

- A table for COVID-19 sport group related administration can be set up inside the Gord Bamford Foundation Skate Lounge upon request.
- Participants must come fully dressed for activities, bringing with them only their helmet, gloves, skates, stick and water bottle. We discourage bringing a full hockey bag. There will be no access to showers or change rooms.
- Chairs for putting on skates are available outside of the arena, in the Gord Bamford Foundation Skate Lounge.
- Benches and chairs for taking skates off are available inside the team room hallway of the arena.
- Goalies have limited space to change into equipment in the Gord Bamford Foundation Skate Lounge and to remove pads in the team room hallway (goalie padding and skates). Goalies should come dressed as completely as possible.
- No lock up space is available. It is recommended to take all personal items to the players' bench.
- Coaches/instructors can have access to the penalty box area as preparation area for the booking.
- Spitting is prohibited
- All spectator bleacher seating will be closed. Spectators may view ice from inside the west arena glass. Please note there is no EXITING to the Gord Bamford Foundation Skate Lounge. All spectators must EXIT from arena north doors.
- Spectators may be asked to leave the facility at anytime if the facility COVID-19 restricted capacity is reached.
- Limited access to washrooms. Your group will be designated participant washrooms within the arena (converted from change rooms). Signage will be posted. Access to the Builders Hall washrooms are available.
- Water fountains that contain beverage container filling will be turned on. Fountains that require lever-action and/or direct-to-mouth will not be turned on.
- Sport organizations must review and adhere to the Alberta Relaunch Strategy documents and their Provincial Sport Organization, Return to Sport Guidelines specific to their sport and the facility they are operating out of.
- If requested, the Safety Plan must be submitted to RDC. For sport user groups who do not have a COVID-19 Safety Plan, the RDC COVID-19 Exposure Control Plan must be followed.
