Disciplinary committee – for all non-official related incidents

- Committee members are Bruce, Marc B, Dusty, and Stacy at least 3 have to be included on each incident
- All incidents must be reviewed within the allotted time that the policy states

RIC expectations for the season – need to review and fix job description where necessary

- Evaluations need to be signed by oth the ref and the RIC
- Evaluations need to be given a copy on the night of the game so that they can review and learn from it.
- RRLA should receive their copies weekly to ensure none are missed though out the season
- Level 1-2 refs should be evaluated at least 2 time in May and other 2 in June. If there is no improvement in issues then game assignments may need to be re-evaluated
- Level 3-5 refs should be evaluated once at the beginning of the season and once more near the end
- We need to create employee Type files for all referees and their evaluations are put in them for future reference
- Need to have storage space available to store these files
