New Business:

- **Team Numbers/Issues to solve/Need coaches for U7/U9**
 - 6 & 7 kids on Cochrane U7 teams due to low numbers (2 Airdrie, 2 Cochrane) - 31
 - U9 - 5 teams of 13-14 players each (3 Airdrie, 2 Cochrane) - 72
 - U11 - 83 runners, 5 teams of 16ish players - only 4 goalies. Need 1 more. Shannon and Rick to send out an email to U11 for goalie. - A, 2B, 2C
 - U13 - 58 runners, 4 goalies - 4 teams - push for A, B and 2C teams based on skill level.
 - U15 - 60 runners, 4 goalies - 4 teams - A, 2B, C
 - U17 - 45 runners, 2 goalies - 3 teams - A, 2B - email all U15 players to offer 6 players the chance to move up (if they don't make U15A) and possibly play with a friend. Kim will draft an email and Shannon will send it out. Gerald does not agree with moving a goalie up to U17.
 - U7 coaches - 4 head coaches for Airdrie (2 per team) 1 assistant per team (Airdrie), No head coaches for Cochrane, U7 1 team has 2 assistants and 1 team has 1

- U9 - no head coaches for Cochrane, 1 assistant each team in Cochrane, 2 head coaches for Airdrie, 1 team without a head coach. 12 Assistant coaches between 3 teams.
- **RageDays - What do we need to finalize?**
 - Need volunteers
 - Will do a 50/50 raffle
 - Socks - Gerald is finalizing the socks. Should be in by RageDays
 - Gerald will reach out to confirm with Graphnix for online store
 - MMH apparel for on site again? Everyone is good with it if MMH is available
 - Slash will be on site all weekend
 - Liquidate stuff from locker for vintage sales
- **Mouthguards**
 - Should be ready by the end of March. Can distribute at RageDays again
 - Unable to secure a clinic in Cochrane this year
- **Sponsorship Finalization for the year/Name Bars**
 - Concession opening in Crossfield - could not use New York Fries anymore (hoping to keep that relationship by having them come to Genesis for the U9 tournament)
 - Point 8 Power systems presented cheque for sponsorship for U13 and U15 the other day
 - Michelle will reach out to MMH for making name bars
 - U17 sponsorship Slash Jerseys/shorts, CDN brewhouse \$2500 third jersey set for 1 team. Cody looking for sponsorship for this deal for all 3 U17 teams, jersey/shorts/undershirt
- **ALA Screening Policy - what do we have to do to meet this?**
 - Allow the 3 year but has to acknowledge there has been no change each year
 - Shannon to look at it and see what we need to send out or update.
- **U7 at Feel The Rage Tournament or add more U9 teams**
 - Since we only have 3-4 teams in U7, do a jamboree at the end of the season for them and open up the U9 tournament to more U9 teams.
- **Discipline Director Position**
 - Cody as interim as Discipline Director until end of season - Kim motions. Michelle 2nds. All in favour. Motion carries.
