SSA POLICY: A PLAYER SHALL NOT REGISTER OR PLAY FOR MORE THAN ONE TEAM DURING A SEASON, UNLESS HE OR SHE HAS BEEN PROPERLY TRANSFERRED.

ANY PLAYER REGISTERED WITH SSA IS ELIGIBLE TO OBTAIN A "TEMPORARY REGISTRATION - OUT OF PROVINCE PERMIT", WHICH SHALL ENTITLE THE PLAYER TO PLAY FOR A REGISTERED TEAM FROM OUTSIDE OF SASKATCHEWAN IN A COMPETITION TAKING PLACE OUTSIDE THE JURISDICTION OF THE SSA, SUBJECT TO THE RULES GOVERNING THE COMPETITION IN WHICH THE PLAYER WILL PARTICIPATE.

## PROCEDURE FOR TEMPORATY REGISTRATION APPLICATION

- 1. A PLAYER REQUESTING A TEMPORARY REGISTRATION MUST COMPLETE AND SIGN THE "PLAYER INFORMATION" SECTION.
- 2. THE APPLICATION MUST BE FORWARDED TO THE CURRENT TEAM CONTACT.
- 3. THE CURRENT TEAM CONTACT MUST COMPLETE AND SIGN THE "CURRENT TEAM INFORMATION" SECTION.
- 4. THE APPLICATION MUST BE FORWARDED TO THE TEMPORARY TEAM CONTACT.
- 5. THE TEMPORARY TEAM CONTACT MUST COMPLETE AND SIGN THE "TEMPORARY TEAM INFORMATION" AND "COMPETITION INFORMATION" SECTIONS.
- 6. THE APPLICATION MUST BE FORWARDED TO THE CURRENT MEMBER ORGANIZATION.
- 7. THE MEMBER ORGANIZATION MUST COMPLETE AND SIGN THE "MEMBER ORGANIZATION APPROVAL" SECTION.
- 8. THE APPLICATION MUST BE FORWARDED TO THE SSA ALONG WITH THE \$25.00 ADMINSITRATIVE FEE.
- 9. APPLICATIONS CANNOT BE PROCESSED UNLESS THEY ARE COMPLETED IN FULL AND ACCOMPANIED BY THE ADMINISTRATIVE FEE.
- 10. THE SSA SHALL REVIEW AND APPROVE THE APPLICATION.
- 11. THE PLAYER IS NOT ELIGIBLE TO PARTICIPATE IN MATCHEW WITH THE TEMPORARY TEAM UNTIL THE APPLICATION HAS BEEN APPROVED.
- 12. THE PLAYER IS REQUIRED TO PROVIDE THEIR OWN TRAVEL INSURANCE FOR THE DURATION OF THE TEMPORARY REGISTRATION
