**PROCEDURE FOR YOUTH REINSTATEMENT APPLICATION**

THE APPLICATION IS TO BE USED BY YOUTH-AGE PLAYERS (18 YEARS OF AGE AND YOUNGER WHO ARE CURRENTLY OR WERE LAST REGISTERED WITH A SENIOR (ADULT) TEAM AND WISH TO BE REINSTATED TO YOUTH STATUS IN ORDER TO PARTICIPATE WITH A YOUTH TEAM

1. A PLAYER REQUESTING YOUTH REINSTATEMENT MUST COMPLETE AND SIGN THE "PLAYER INFORMATION" SECTION
2. IF CURRENTLY REGISTERED WITH A SENIOR TEAM, THE APPLICATION MUST BE FORWARDED TO THE SENIOR TEAM CONTACT
3. THE SENIOR TEAM CONTACT MUST COMPLETE AND SIGN THE "SENIOR TEAM INFORMATION" SECTION
4. IF NOT CURRENTLY REGISTERED WITH A SENIOR TEAM, THE PLAYER SHOULD COMPLETE THE "SENIOR TEAM INFORMATION" SECTION WITH THE INFORMATION FROM THEIR LAST SENIOR TEAM
5. THE APPLICATION MUST BE FORWARDED TO THE RELEVANT SENIOR MEMBER ORGANIZATION
6. THE SENIOR MEMBER ORGANIZATION MUST COMPLETE AND SIGN THE "SENIOR MEMBER ORGANIZATION APPROVAL" SECTION
7. IF THE PLAYER IS TRANSFERRING TO A YOUTH TEAM, THE APPLICATION MYST BE FORWARDED TO THE YOUTH TEAM CONTACT
8. THE YOUTH TEAM CONTACT MUST COMPLETE AND SIGN THE "YOUTH TEAM INFORMATION" SECTION
9. IF THE PLAYER IS TRANSFERRING TO A YOUTH TEAM THE APPLICATION MUST BE FORWARDED TO THE RELEVANT YOUTH MEMBER ORGANIZATION
10. THE YOUTH MEMBER ORGANIZATION MUST COMPLETE AND SIGN THE "YOUTH MEMBER ORGANIZATION APPROVAL" SECTION
11. THE APPLICATION MUST BE FORWARDED TO THE SASKATCHEWAN SOCCER ASSOCIATION ALONG WITH PAYMENT OF THE \$25.00 ADMINISTRATION FEE
12. IF THE PLAYER IS NOT TRANSFERRING TO A YOUTH TEAM, THE APPLICATION MUST BE FORWARDED TO THE SASKATCHEWAN SOCCER ASSOCIATION ALONG WITH PAYMENT OF THE \$25.00 ADMINISTRATION FEE
13. APPLICATIONS CANNOT BE PROCESSED UNLESS THEY ARE COMPLETED IN FULL AND COOMPANIED BY THE ADMINISTRATION FEE
14. THE SASKATCHEWAN SOCCER ASSOCIATION SHALL REVIEW AND APPROVE THE APPLICATION
15. THE PLAYER IS NOT ELIGIBLE TO PARTICIPATE IN YOUTH MATCHES UNTIL THE STATED DATE ON THE APPROVED APPLICATION
