

Summary of responses:

 Majority of MO state that their finances and capacity will be stable. Most organizations will be using reserves to top up their outdoor revenue but might not be able to bring back some of their paid staff. Volunteer engagement will be important but MO worry that they may not be able recruit the required volunteers. 



- Modifications required for example, 15 minute breaks between training sessions/games to minimize contact during session switchover.
- Possibly no spectators allowed
- Facilities associated with schools might have to wait until schools reopen
- Facilities currently closed, will have to wait for them to reopen

Possibly, depending on what it is that other clubs are in need of??


Considering a #meet me at the park initiative. Using the fields in local areas around the city for drop in training sessions led by our coaches or older players. No charge.
