- Lax Day in Sask March 29th in Saskatoon

 - \circ $\;$ Rush more involved in the planning and promotion of the event
 - 36% increase in registrations over previous 2 years
- Lacrosse Canada Fee Increase Reminder The following fees were provided as a reminder to Assocaitions that their new costs would be as follows
 - i. Annual Member Association Fee \$50
 - ii. Team Fee \$50 per team
 - iii. Player Fee \$42 per player (Box or Field)
 - iv. Dual Athlete Fee \$61 (Both Box and Field)
 - v. Coach Fee \$25 per coach
 - vi. Official Fee \$25 per official
 - G. Krawetz and R. Cherkewich advised that the fee increase from Lacrosse Canada came into effect in 2024 but SLA covered the difference. This year it would be the Association responsibility to pay the increase, so they need to plan accordingly. No questions were asked.
- ED update
