2025 Women's Sector Report

2025 was another positive year for women's lacrosse in Saskatchewan. The amount of participation of females in the sport continues to grow every year from the grassroots level up to the provincial teams.

The Team Sask Female Box Lacrosse Team at the 2025 Canada Summer Games came out strong and ended up tied for first in their division after the round robin. They ended up finishing 7th after a final win against NB. It was an amazing experience for these athletes and for a few, a rare second opportunity to attend the Summer Games. Thank you to Coaches Matthew Dalton, Paige Mason and Jessica Benning.

Saskatchewan was able to send a team to the Jenny Kyle Cup again this year. This is the U19 Women's Field Lacrosse Nationals and it was held in Coquitlam BC in July. Team Sask saw great improvement from game to game and while they finished last in the tournament, they had an amazing experience and each of them came away with more knowledge and skills. Thank you to Coaches Paige Mason, Matthew Dalton and Shea Roblin.

Saskatchewan sent 2 female teams to Halifax for Box Lacrosse Nationals in August in the U13 and U15 divisions. The U13 team finished 5th and the U15 team finished in 6th. As always, the games against the powerhouses of BC, Alberta and Ontario were tough. Thank you to U13 Coaches Randy Labrecque, Krysta Williams and Callie Dammann and U15 Coaches Greg Krawetz, Theron Prodaehl and Avlyn Soucy.

There was not enough interest from Sask athletes for a U22 division team. This age group struggles as many in this age group are finding full time summer jobs to help pay for secondary education, etc and practices through the summer plus taking a week off in mid-August to attend Nationals is tough for many.

This fall brought a push across the province to try Women's Field lacrosse. Some MAs offered local programming and some presented opportunities for females to give the sport a try on their Festival days, with help from team members of the U19 Female Sask Team. A couple of the events had up to 18 girls at a session. While there wasn't enough participants for games, the seed has been planted and we will continue the momentum in 2026. Thank you to the MAs who donated their equipment and volunteers to these sessions.

Sixes will also be a great opportunity within the women's sector as our main struggle is numbers and sixes helps with that challenge.

As with all sectors, the struggle is to find coaches, officials and floor/field time. In 2026 we hope to be able to offer women's field coaching courses and another officiating course. The number of older athletes giving back as coaches and officials is wonderful to see and I hope this trend continues. The future is bright!

2025 SLA BOX PROVINCIAL'S CONVENORS REPORT

OVERALL ASSESSMENT

The major change to Provincials this season was hosting a week earlier than normal. Rather than hosting in July after the Canada Day weekend, Provincials were held from June 27th – 30th and more teams attended due to this.

The revised Provincial format was used once again this year with divisions successfully categorized into A, B, and C tiers. The A Division included teams from the Sask A Box League, while for House Provincials, teams were allocated to B or C based on their performance and the presence of double-carded athletes. This approach ensured closely contested games and provided equitable playing opportunities for smaller Member Associations (MA's) and areas without double-carded players.

This format allowed teams that had faced heavily double-carded opponents all season, sometimes without scoring a goal, to secure their first win against teams of comparable playing levels.

Under this updated format and the capability to segregate into distinct divisions, there was a notable reduction in "blowout games" compared to previous years. The few instances of such games transpired. All teams seemed to enjoy themselves for the weekend.

While the arenas were warmer than what would have been comfortable, everyone monitored the conditions and ensured players were safe and hydrated. The host and SLA brought in fans to help cool the players.

EVALUATION OF HOST ASSOCIATION

Regina demonstrated their ability to host this event. Managing a tournament spanning five days is never a small feat, and everything was executed well. Using three arenas in the Cooperator's Centre proved sufficient to host the required number of games and very convenient for families with multiple players and they did not need to travel around the City. The host was able to secure enough hotel rooms for the teams attending and the City is host to ample restaurants for feeding the families.

Regina also hosted the U11 Festival to coincide with the Provincial house tournament and it was great to see all teams from U11 through U17 in one location at one time. There were ten U11 teams from across the province that attended the festival. This earned praise from attending families and creating a memorable experience for the teams. The event's success reflects Regina's commendable efforts in organizing and executing the tournament, and we express our gratitude for their willingness to take on the responsibility this year of hosting everything at one time.



COMPETITION

The A Provincials had all four teams in the league participate this year in the U13, U15 & U17 divisions (Regina Barracuda, SSSL Stealth, Saskatoon SWAT, and North Sask Predators). This year there was the following number of teams in each Division for House Provincials:

- U13 – 10 – Standing Buffalo Fighting Sioux, Shellbrook Swarm, Saskatoon Hurricanes 2.0, Weyburn Security Thrashers, Moose Jaw Mustangs, Weyburn Young's Equipment Thrashers, Regina Chaos Green, Regina Chaos Blue, Regina Chaos Grey, Swift Current Rampage
- U15 – 8 – Melfort Wings, Moose Jaw Mustangs, Regina Chaos Green, Regina Chaos Blue, Standing Buffalo Fighting Sioux, Saskatoon, Swift Current Rampage, Weyburn Young Fellow Thrashers
- U17 – 4 – Regina Chaos Blue, Regina Chaos Green, Moose Jaw Mustangs, Weyburn Panther Drilling Thrashers

The introduction of the new format has contributed to narrowing the skill gap, resulting in fewer blowout games and a more substantial number of close and exhilarating matches. The A, B, and C divisions all offered compelling lacrosse competitions, providing valuable opportunities for players across various skill levels. The 22 teams in attendance across three divisions was the largest participation of teams in the last five years, and can be attributed to the change of dates. There is still work to do, as we were missing teams from one of our largest Associations in Prince Albert. Additionally, in the U17 division all teams were once again from the south, which was a disappointment to the teams as they had played each other multiple times already this season.

OFFICIATING

There were minimal concerns with officiating, there appeared to be enough officials to cover the number of games. The Referee-in-Chiefs (RICs) played a commendable role in assisting the officials with their requirements. The host thoughtfully provided dedicated rooms for the officials, stocked with snacks and drinks. The officials maintained effective control over the games.

DISCIPLINARY ACTIONS

There were no suspensions or incidents that required a discipline committee to be created for the tournaments. No players or staff were suspended in the tournament.

RECOMMENDATIONS

- Work still needs to be done to ensure larger associations have teams attending. Too much focus has been put on the A teams and Ho
- The continued use of A, B, C divisions or variations for Provincial Championships aligns lacrosse with the structures commonly seen in other sports. However, it is acknowledged that the presence of double carding poses challenges when it comes to the divisional categorization of teams.
- The A Provincial format needs serious review for the coming seasons. The A division has remained stagnant and seems to be a priority over house play for many associations.
- It is recommended that the Sector review the future direction of A Provincials, including their necessity, with only a maximum of 4 teams being involved. Review to determine if playoffs could be decided in June with a league date rather than being included in the Provincial format, which extends the length of Provincials on all people involved and at an extended cost.
- It is recommended that coaches ensure their certification is completed within the first month of the season. It is a LC requirement to have proper certification to be on the bench, this should not be an issue come Provincials, as it should be completed at the start of the season or shortly after.
- All officials and coaches must be registered in RAMP, as this is not being followed by many associations.

2025 Field Sector Chair Report

The 2025 Field lacrosse season was, overall, a positive one for the Saskatchewan Lacrosse Association. We saw strong participation in the younger divisions and continued engagement across much of the province. The U9 to U15 divisions were particularly well attended, with athletes and families showing great enthusiasm and commitment to their local programs. The growth and stability in these age groups demonstrate that our grassroots foundation remains strong and continues to be a vital part of the field sector's success.

The older divisions, particularly U17 and U20, continue to present challenges. Many athletes in these age groups are choosing to participate in fall elite programs rather than local house leagues. While these opportunities are encouraged and provide valuable experiences for our players, there is difficulty for Member Associations to sustain consistent rosters and programming at the local level. This remains an area for continued focus and discussion moving forward.

The fall field model has proven successful for most Member Associations, though there are notable exceptions. Swift Current, Sturgis, and Saskatoon have each experienced challenges making fall field work effectively compared to their traditional spring seasons. This variation suggests that regional flexibility may continue to be necessary as we refine our seasonal approach. However, more commitment from these associations to offer fall programming may mitigate the issues at-hand.

Planning for the Field season will need to begin earlier in the year to ensure smoother coordination among Member Associations and programs. This season also highlighted the need for earlier deadlines for team commitments to Provincials. Last-minute roster changes and team withdrawals created significant scheduling challenges, and addressing these issues proactively will benefit all involved.

Prince Albert Lacrosse Association deserves special recognition for hosting an excellent U11 to U17 Provincial Championship. The event was well organized and provided a positive experience for athletes, coaches, and families. Regina, Yorkton, and Moose Jaw also hosted successful Festivals throughout the season. In Saskatoon, the Saskatchewan Lacrosse Association hosted a Field Festival in place of SFLA as they chose not to enter teams in Festivals. The event was well received and provided meaningful competition opportunities for those programs that participated.

At the high-performance level, U17 Team Saskatchewan had an acceptable year, finishing fifth at the Alumni Cup in Nova Scotia. The team lost two close games to Nova Scotia and Alberta, showing that they are competitive at the National level. This group shows great promise if they can remain together and continue to develop.

Unfortunately, Saskatchewan was once again unable to field a U19 Team Saskatchewan program due to many athletes being away for college lacrosse commitments. Renewed focus on this age group will be necessary to ensure we are consistently represented at the First Nations Cup in future seasons.



This season also marked an important milestone for Saskatchewan on the international stage. Five athletes and one coach from our province were selected to their respective Team Canada West rosters as part of Lacrosse Canada's National Team Development Program, "Canada Futures." Their selections highlight the growth of talent emerging from our programs and the quality of coaching and development happening locally. Furthermore, two female athletes who played for Team Saskatchewan at the Canada Summer Games have been identified to tryout for Canada Futures in 2026. In addition, Saskatchewan has been identified by Lacrosse Canada to host one of three regional Identification Tryout and Symposium Weekends in 2026, a significant recognition of the province's leadership and capacity within the Field lacrosse community. This opportunity will provide valuable exposure for our athletes and coaches while further integrating Saskatchewan into the National Development Pathway.

The Saskatchewan Field Lacrosse League (SFLL) experienced a challenging but ultimately competitive season. While participation throughout the regular season was a struggle, the league concluded on a high note with an exciting and competitive Harvest Cup Provincial Championship weekend in Sturgis. The event showcased strong play and commitment from those teams and athletes who remained engaged through the season. However, continued discussion will be required to determine how best to sustain the league while still providing meaningful and competitive opportunities for senior athletes moving forward.

The Women's Field program also had a strong year. Although the U19 Team Saskatchewan finished last at the Jenny Kyle Cup, the athletes displayed excellent attitudes, teamwork, and growth. They also had the opportunity to participate in a multi-day training camp in Outlook that featured a Team Canada athlete as a guest coach, which was a valuable developmental experience for the group. At the local level, the SLA hosted inaugural Women's Field Try Lacrosse sessions at multiple Field Festivals during the season. These sessions were attended by girls of many ages. For 2026, the SLA plans to provide more clinics and Try Lacrosse sessions with the goal of having Women's Field games as part of the Festivals and Provincials weekends.

Looking ahead, the introduction of Sixes and development events in the winter of 2025–26 will provide athletes with additional opportunities to develop their skills and maintain engagement during the off-season. Continued emphasis on grassroots programming remains a top priority to ensure long-term growth and sustainability within the Field Sector.

As we reflect on the season, several lessons have emerged. Early planning and communication are critical, and policy discussions may be necessary regarding athlete participation in house programs alongside joining elite fall teams, as well as team eligibility for festivals and provincial events. These discussions will help create consistency and accountability across the province.

In summary, the 2025 Field lacrosse season was productive and encouraging. Participation was strong at the grassroots level, our competitive programs continue to evolve, and both the men's and women's field sectors show signs of progress. With continued collaboration and early planning, the Field lacrosse community in Saskatchewan is well positioned for another successful year ahead.

Convenors expressed satisfaction with the officiating, noting that it was well-managed. The Referee-inChiefs (RICs) at the tournament demonstrated effective oversight, adeptly addressing any issues that arose and offering valuable mentorship. It was nice to see some younger officials getting experience at this year's provincials.

Disciplinary Actions

No suspension or incidents occurred which required a disciplinary committee to be formed.

Media

Multiple teams involved in these years provincials were very active on social media presenting the scores from their games as well as showcasing some players achievements.

Recommendations

-More of a presence on social media for the "Saskatchewan Lacrosse Association". I think that we should be showcasing our game scores, all-stars, and other media to ensure we showcase our athletes' success.

-The further inclusion of Women's Field or Sixes should be done to continue to enhance diversity and participation of our female athletes

-Need data sim cards for the Ipads that are used for game scores. Connection was a big issue for our systems and it affected us from getting the scores from each game.



-The timing of provincials has proven again that it is in conflict with other sports going on. It was the first time we had to see a medal game forfeited because half of the Regina team had to attend hockey tryouts back home.

Overall, Prince Albert did a great job hosting this year's provincials once again. The venues were very well taken care of, the officiating was very well done, and the athletes had an amazing time playing the Creators game. Looking forward to how we can make next years provincials another one to remember.
