SSGHA ANNUAL GENERAL MEETING MINUTES 2022

- 1. Meeting called to order by Moderator, Krista Montgomery at 8:34pm beginning Instruction provided on how to vote and how to leverage Zoom tools
- 2. Motion to accept 2021 AGM minutes First: Kevin Hinchey and Second: Aleah Longaphie Voting- motion passed 16-2
- 3. **League Update** delivered by Chris Crosthwaite, Disciplinary Director Our overall registrations numbers were lower than a typical year, but that was to be expected coming of the previous year without a house league and with the uncertainty of COVID.
 - Total Sharks registration for both HL & Rep was 487 compared to 574 in 2019/2020 (pre-COVID)
 - This is broken down to HL with 210 vs 240 and Rep was basically flat with 277 (including 70 Senior) vs 216 (last year where we didn't have any senior teams) and for reference rep #'s were 344 (pre-COVID)

In Rep, we increased to 15 rep teams this year, that's one additional team compared to last year's total. It was successful seasons from many of the rep teams with numerous tournament medals. We had 5 teams advancing to the Provincials and with 1 Silver Medal from the Senior A (Misketis).

Our House League was healthy again this year with 21 teams in 5 divisions, as usual we could always use a few more players to help round out some of the divisions, but overall we had a successful year coming back from no HL the previous season.

 Notable... we were able to move 13 First Shift Players into our HL program – showing that grass roots hockey works

Speaking of Grass Roots hockey, we had three initiatives:

- 1. One of the original reasons we came to the Sharks in the first place was our Little Sharks Program which had another successful year with 17 girls registered.
- We also partnered with the Bauer First Shift program to run a successful 6-week introduction to hockey program. The on ice portion of the program was led by Lindsay Collins and introduced 30 young girls to the game of hockey. This is where 13 players transitioned over to our House League Program.

3. And finally, you may have seen on TV, a number of Sharks teams braved the frigid temperatures in late January 2022 to participate in on-ice activities as part of Rogers Hockey Day in Canada. This year's HDC event held at McCowan District Park in Scarborough and they put the spotlight on Scarborough's hockey community with a theme of "Hockey for All". Celebrating and highlighting diversity and inclusion in the game.

As you likely remember not everything was without its challenges this year; as the province shutdown hockey activities in Dec & Jan which cancelled our tournament for a 2nd year. Also many teams had to deal with multiple schedule changes due to Covid impacts on both our Sharks teams and our competitors.

I would like to take this opportunity to thanks my fellow executives and the team volunteers that helped us get through another season under difficult and ever changing conditions. It definitely takes a village to run a hockey organization.

With this in mind, there are some special shout outs to a few people I like to make as we have a number of people leaving the executive and leaving as volunteers for the sharks...

So Special thanks to: Keith – who has been on the executive for 10 years – the bulk of those years as League Treasurer Ariel – 4 years as VP HL Jennifer – 4 years as Secretary Krista – 3 years as Player Development

Greg and Lisa Clarke who have been with the league since their daughter started in the U9 program in House League. Both gave two extra years of volunteer time after their daughter went to university.

And finally, I would like to send a special shout out to Shirley who tirelessly works in multiple roles (assuming some of the President's responsibilities) to keep this organization together.

Thanks to all, as I said it truly takes a village....

One final point... We were pleased to receive feedback from the Sharks families that completed the annual satisfaction survey, it was clear that the vast majority of responses were satisfied with the programs offered by the teams again this year.
