**CANCELLATION POLICY**

If a Player cancels prior to April 9<sup>th</sup>, the Player will be entitled to a full refund less the non-refundable \$50 tryout fee and a \$100.00 administration fee. If a player cancels after April 9<sup>th</sup>, and before May 1<sup>st</sup>, the Player will be entitled to a refund 75% of the Player's registration fee less the non-refundable \$50 tryout fee and a \$100.00 administration fee. If a player cancels after May 1<sup>st</sup> and before May 15<sup>th</sup>, the Player will be entitled to a refund 50% of the Player's registration fee less the non-refundable \$50 tryout fee and a \$100.00 administration fee. There will be zero percent (no refunds) for cancellation after May 15<sup>th</sup>, unless the Player has been injured. If the Player has been injured the refund will be pro-rated.
