6. Treasurer's Report:

7. Director Reports:

• Coaching (Jared)

- o Have appointed the A coaches for Peewee and Bantam and Midget
- Have most coaches for the B teams. Names have been provided to Directors
- Will be meeting with the head coaches and directors to plan the evaluations
 - Evaluation structure
 - Outside evaluators
 - Grading scale and process
 - Two scheduled floor times per player
 - Cost \$40 to try out for A teams to cover floor costs
 - Times TBD
 - Beaumont players that do not make the A teams are released back to their home club
- Really need the coaches and directors to stress importance of stick sizing at Tyke/Mini-Tyke.
 - Suggesting this can be part of drop in events, take a measurement of the kids sticks, explain to parents the proper lengths for kids.
 - Suggesting directors ask older kids they know to come help with sticks, maybe even offer stick restringing at drop in event
 - Jared will put information about stick sizing etc. On the webpage.
 - Jared will put coaching application form on the webpage
 - Sarah will send him the log in information he needs it resent.

• Apparel (Mike):

Midget (Jim):

Post Midget (Jim):

• Tournament (Harry for Tracy):

- ALA has new requirements for teams wanting to attend tournaments. They will need to fill out a travel request form.
- o ALA only approved the Titans tournament for Peewee to Midget for boys (removed the novice boys from our request, no reason given)
- o ALA approved the Titans tournament for novice to midget for girls.
- New rules from ALA for tournaments regarding length of games could be possible reason for allowing fewer divisions in the tournament
- Price increase for the tournament was to be discussed:
 - \$650 currently and move this item to next meeting for discussion
