Registrar Kelly Daniels suggested a small increase of \$51 to the Active Start registration fee. Justification included:

- 1. Most associations do not offer any discount and any increase would have SPRA more inline with similar associations.
- Active Start is subsidized by the older age groups and instead of covering Active Start costs the older age groups could get additional monies for SPRA offered development
- 3. Prepares families for the U10 Registration fee.

The increase was rejected during a discussion amongst the attending board members.

Registration - 2023-2024 Player Registration Fees

Updated by 2023/2024 Registrar. Reviewed and adopted at May 2 SPRA Executive meeting.

New first year player fee – \$150 plus \$61 RAB fee for a total of \$211 for U10, U12 and U14 Divisions. Applicable for any "new to ringette" player, playing ringette for the first time.

NOTE: Ringette Fee gets paid directly to Ringette Alberta. SPRA has no ability to refund these dollars.

Fundraising Fee

Raffle tickets will be distributed in October.

You will have an opportunity to recoup you fundraising fee by selling your raffle tickets. The Raffle this year will continue as a "Cash for Christmas" raffle.

U10 Registration Fees

U10 fees scales to coincide with Ringette Canada's Children's Ringette Guidelines and recommended number of practices and games during the season. Step 1 and Step 2 will play half-ice games for the 2021/221 Ringette Season. Step 3 will continue to play full ice games. All U10 registrants will pay the base fee at time of registration. As participants are assigned to teams based on the criteria set out in Children's Ringette Guidelines, SPRA will add the additional applicable fee for U10 Step 2 or 3 to your account and provide notice by e-mail from SPRA's registrar to indicate an additional fee is payable and will be added to members payment plan.

Late Registration

Season Registration closes on August 1. Registration following the close of season play will be reviewed and if accepted assessed a \$75 late fee penalty.

Players joining late in the season may receive a reduction in fees depending on the circumstances after a review by the executive.

Evaluations

For specific information about the evaluation process, please refer to Evaluation Guides that will be posted on SPRA's website for each Age Division by August 1, 2022. Evaluation Schedules will be released mid-August. SPRA has a significant amount of evaluation ice scheduled over the September long weekend.

Deadline to register for AA Evaluation is August 1, 2023. There will be no late registration accepted.

Refunds

Refunds must be made formally in writing by email to the Registrar, President & Vice President. The date the request is made will be used in calculating the amount for the refund. If the teams have already been formed, the request for refund must also include the Coach, Manager and Division Director.

Requests for refund prior to the start of evaluation will received a full refund including the Fundraising fee.

Requests for refund after evaluation have started and prior to the formation of teams will receive a full refund including the Fundraising fee less a \$50 Administrative fee.

Requests for refund after team formation prior to November 1 will received 75% refund of Registration fees. No refunds for fundraising fees after the raffle tickets have been distributed.

Requests for refund prior to December 15 will received 50% refund of Registration fees. No refunds for fundraising fees after the raffle tickets have been distributed.

No refunds will be granted after December 15. Requests for extraordinary circumstances may be considers following a formal written request submitted to the President and the Division Director.

Why Register Now?

SPRA encourages all our members, if they intent to play ringette this 2023/24 season, to register now. This helps our association plan for the start of the season.

Register between June 1 and July 1 and you attended the April 2023 SPRA AGM, you are only required to pay a deposit of \$150 for your account to be credited \$50 on your account to apply to your registration fees when due. *New to Ringette and Active Start not eligible for payment Plan.

Payment Plan

\$150 Deposit – June 1 – August 1(plus RAB \$61 fee)

\$50 Credit applied to members account that attended the April 2023 AGM. (Applies to registration for each player in the family) and registration is completed by July 1.

1st Payment – September15

2nd and Final Payment – November 15
