# BOYS RULES REWRITE

Executive Director's notes from the February 5 Minor Advisory Council Meeting

The group tasked with reviewing Article 9 - Minor Boys Fastpitch Rules has not completed their work.

Their recommendation, as presented at the last Board meeting, was add this new clause to the rules:

9.1.15 CLASSIFICATION – all minor boys teams will be classified as C (Community). As such tryouts and all star teams are not permitted. All references to Rep B and A classifications in Article 9 are null and void.

The Board did not approve the addition and supported the recommendation to have staff include the following statement at the beginning of Article 9.

Softball BC is currently re-writing Article 9 to eliminate references to B and A, thereby categorizing all teams as C (community ball) effective this 2025 season. As a result, tryouts are not allowed.

<u>Note</u> - that categorization shall only be used to form teams to send to Western or Canadian Championships.

The Executive Director will collaborate with the Chair of the MAC to complete the review of the Boys' rules and issue a bulletin when it is ready to share the new version of Article 9 with the members. Appropriate notices will be placed on the website and other platforms.

## **15.8 Classification of Minor Players**

The Minor Advisory Council approved this motion during their meetings on January 8, 2025, and February 5, 2025 (see page 2). However, it was not posted on Softball BC's website for member feedback between the votes due to the short turnaround time required to produce the handbook.

#### Implications for Boys' Teams:

The committee responsible for drafting a new version of Article 9 for Boys, which no longer refers to B and A categories, has not yet completed their work.

As directed by the Board, the Executive Director will collaborate with the Chair of the Minor Advisory Council to finalize the review of the Boys' rules. A bulletin will be issued once the review is complete to inform and share with members the new version of Article 9. Notices will be appropriately placed on the website and other platforms.

In the meantime, we recommend that the Board approve the following addition to the handbook, which will immediately follow rule 15.8:

Softball BC is currently rewriting Article 9 to eliminate references to B and A, categorizing all teams as C (community ball), effective for the 2025 season. The rule rewrite will also outline how teams will be identified for Western or Canadian Championships.
