Subject: Procedures for Pro Tem Suspensions

Please note the following excerpts from Softball BC Special Operating Rules that outline the procedures to be followed when assessing a Pro Tem Suspension.

4.1.4 PRO TEM (interim) suspensions of less than 31 days may be issued in exceptional circumstance (i.e. flagrant abuse (verbal or physical) or an umpire, player, fan or official; Criminal or civil misbehaviour; gross misconduct relating to, and/or defiance of, established Special Operating Rules):

- a. Upon agreement between the appropriate District Umpire-in-Chief and District Coordinator;
- b. In the case of Provincial Championship, by the Board Member, or their designate in charge of the Championship.

4.1.5. EXPIRY Disciplinary actions, including Pro tem suspensions, shall be deemed to have Expired 31 days after they have been issued at 2400H, however further disciplinary action could be imposed in accordance with Article 4.1.

When a pro tem suspension is to be used

4.1.4.
