- 1. Call to order 10:35 a.m.
- 2. Quorum was established
- 3. Agenda was approved KL/DV/all in favour
- 4. January 30 minutes approved BH/KL/all in favour
- 5. Business arising:
 - a) U11 Celebration of Softball
 - District 1 is in support, has a host and will also invite District 2 teams to attend
 - District 6 is very supportive but it may not work this year for them due to activities already in place
 - District 7 is in support and already has a host and dates selected for the event with the final game to be played at Softball City just before a Canada Cup game
 - District 8 is not supportive at this time because of prior scheduled activities but some teams may combine with the D7 event for teams that are interested
 - District 9 had concerns about the timing and other events happening but will discuss again at their next meeting
 - District 10 is very supportive and working on dates and host
 - District 12 is supportive and has a host for June 11th and 12th and will invite teams from District 13
 - District 14 is not supportive because it conflicts with their closing activities
 - District 15 is supportive but may not work well this year due to timing of activities

A recommendation to proceed will be made to the Board of Directors at the Feb. 18th meeting.

6. Chris Young provided a report on the Minor Development Fund

There is approximately \$19,000 to disperse for 2022 season. There is also a GIC valued at \$21,000. Coordinators are asked to encourage their associations to apply for funding for things like clinics, travel and ferry subsidies, support for bringing softball into schools, advertising, opening/closing events, etc. To apply for funding, associations can send a detailed email to Chris Young at D14minorcoordinator@softball.bc.ca providing all details of the request. Any other ideas for the use of the fund should be sent to Chris Young.
