

Minor Advisory Council minutes

December 16, 2020 6:30 p.m.

- 1. Call to order 6:37 p.m.
- 2. Quorum established 37 votes were present
- 3. Approval of agenda moved by Kevin, seconded by Liz all were in favour
- 4. Approval of the November 25, 2020 minutes moved by Kevin, seconded by Al all were in favour
- 5. Motion change to NCCP coaching requirement for U14B moved by Deb, seconded by Kevin Discussion regarding if motion was passed for 2021 that exceptions should be granted for coaches who were not able to find appropriate training for the upcoming season. Lavaughn explained that the Director of Coaching could grant exceptions if coaches were unable to achieve appropriate training.
 - Vote was called unanimous, all 37 votes were in favour
- 6. Motion Play at Home for 2022 moved by Chris, seconded by Deb Discussion revealed that there is some possible confusion in the interpretation of this motion and it needed to be amended so that the intent is clear. This motion was withdrawn by Chris and will be re-written by Chris and presented to the MAC at our next meeting. All coordinators are asked to email Chris with their concerns or questions as soon as possible.
- 7. Minors Playing in Men's and Women's motion 1 moved by Kevin, seconded by Bre Discussion: A question was asked about sections 7.3 e and f as well as 8.3 e and f in the proposed revisions to the rule. It was determined that those sections needed to be removed from this motion. An amendment was moved by Ed and seconded by Kevin. The amended motion was passed by 32 votes in favour, 2 votes no and 3 votes abstained.
- 8. Minors Playing in Men's and Women's motion 2 moved by Kevin, seconded by Deb There was some discussion regarding this motion and it was then called for a vote. The motion has passed by 29 votes in favour and 8 votes no.

10. Vacant provincials for U14C and U19C

11. New business

D7 proposal

Kevin brought forward a proposal from District 7 in an attempt to keep players from shopping around at tryout time. They suggest a tryout fee be established by all associations (likely in the lower mainland only as it would not affect most other areas). It would have to be a substantial fee so that it would deter the player from going to multiple tryouts. If the player was offered a spot with the team, then they would use that fee as part of their registration. If they were not offered a spot, the fee would be non-refundable. It was noted that players who were accessing KidSport funding to play would be somehow exempted from this fee. Kevin asked that the coordinators please send him their comments, suggestions and questions as soon as possible.
