### WHEREAS:

Districts 1 and 2 outline the major centers of each district with no defining boundaries noted;

### AND WHEREAS;

The boundary agreed to and contained within the amended motion #1 from the 2009 AGM minutes does not correspond with the present official map or the understanding of the NDMFA;

# AND WHEREAS;

Not following the intent of the aforementioned motion has caused needless actions by officials of all levels.

# **BE IT RESOLVED THAT:**

The boundary between Districts 1 and District 2 be revised to be designated as the Cowichan Valley and defined as the center line of Highway 18 which runs east/west from the Village of Lake Cowichan (in District 1) then continuing as 'Herd Road' in an east/west direction to meet the centerline of 'Arbutus Avenue' in Cowichan Bay.

### **RATIONALE:**

The Cowichan Valley is a defining and separate geographic area and includes the City of Duncan, parts of the Municipality of North Cowichan, and some rural area. However, in the past, District 1 took the boundary as the north boundary of the Municipality of North Cowichan, going against the intent of the 2009 AGM amended motion. A boundary Committee of representatives from both Districts agreed that the Cowichan Valley was the boundary with the City of Duncan and Village of Lake Cowichan being part of District 1 with no mention of the Cowichan Valley RD or Municipality of North Cowichan. There is a common tie with residents of Crofton, Chemainus and Saltair to Ladysmith and Nanaimo for extracurricular activities such as shopping, sports and recreation.

There is no penalty for these teams apart from a financial penalty and for some teams that is not a concern. Softball BC commits whatever team allotment is given to BC for the Westerns or Canadians. There are too many teams that decline to attend because they did not finish in the position that they wanted. Last year we were told by members at the Burnaby meeting that they wanted as many spots as possible. Softball BC acted on that and then we get teams turning the offer down after they have submitted their Letter of Intent. Teams have committed right up to the final games and then bowed out, then the office has to find teams that have not already disbanded to fill the spots.

There are very few true U19 year olds playing minor ball and a good percentage of those who are, also are playing in Seniors as pickups.

Teams are rostering just one 19 year old to try and avoid being moved up. Since the inception there has been a decrease in the number of B teams and the gap in ability of the C teams has increased with more B and even A players dropping into U19C as a way to get a third year of Minor play, but most of those never play a third year as they are away in college, have jobs or move into Senior Ball. This takes away from the true C player's experience. By removing the 19 year olds from Minor ball it would allow growth in the Junior category.
