

# SOFTBALL MANITOBA – GATHERING SIZES

## MINOR DIVISION – REGULATING GATHERING SIZES

- A **maximum of 25 athletes** may participate in a game. Coaches must ensure there are no more than 25 athletes participating during any game.
- A **maximum of 25 spectators** may attend a game taking place on a single diamond. Spectators must follow current Public Health Orders regarding physical distancing. Each athlete is allowed 1 parent/guardian to attend a game.
- Coaches, officials and safety/compliance officers are not to be included in the total number of athletes or spectators and are considered a separate group. The maximum allowed “support” group is as follows:
  - Coaches – Maximum 3 per team.
  - Managers – Maximum 1 per team.
  - Safety/Compliance Officer – Maximum 1 per team. **NOTE: In addition to ensuring that players and coaches are following Softball Manitoba’s Return to Play procedures, the Safety/Compliance Officer will be responsible for recording the names of the athletes, coaches, managers and spectators that are attending each game on behalf of their team. Any individual not identified by a Safety/Compliance Officer is responsible for any penalties that may be imposed as a result of their actions.**
  - Umpires – Maximum 2 per game.
  - Umpire Safety/Compliance Officer – Maximum 1 per game.
  - Umpire Development/Evaluator – Maximum 1 per game.

## ADULT DIVISION – REGULATING GATHERING SIZES

- A **maximum of 25 athletes** may participate in a game. Coaches must ensure there are no more than 25 athletes participating during any game.
- A **maximum of 25 spectators** may attend a game taking place on a single diamond. Spectators must follow current Public Health Orders regarding physical distancing. Each athlete is allowed 1 spectator to attend a game.
- Coaches, officials and safety/compliance officers are not to be included in the total number of athletes or spectators and are considered a separate group. The maximum allowed “support” group is as follows:
  - Coaches – Maximum 3 per team.
  - Manager/Safety/Compliance Officer – Maximum 1 per team. **NOTE: In addition to ensuring that players and coaches are following Softball Manitoba’s Return to Play procedures, the Safety/Compliance Officer will be responsible for recording the names of the athletes, coaches, managers and spectators that are attending each game on behalf of their team. Any individual not identified by a Safety/Compliance Officer is responsible for any penalties that may be imposed as a result of their actions.**
  - Umpires – Maximum 2 per game.
  - Umpire Safety/Compliance Officer/Development– Maximum 1 per game.

Softball Manitoba reserves the right to have a member of the Board of Directors in attendance to evaluate compliance of teams and spectators as per the Return to Play procedures.
