- 4. Slo Pitch Rollout
 - a. 2022 Slo Pitch Package went live on February 28th
 - Hillary Pineau sent direct communication to leagues identified as priority for 2022. She
 will continue rolling out content through social media and Sportsengine throughout the
 week
 - c. Targeting 100 slo pitch teams (double from 2021)
- 5. Summer Student Proposal Update
 - a. Scott Willis provided an update regarding summer student job applications.
 - i. SEED and Canada Summer Jobs applications have been submitted
 - b. Scott Willis has reached out to local MLA's throughout Regions 3,4,5 (where jobs were requested) and provided additional information on the Caravan Program
- 6. Storage Unit
 - a. Hillary Pineau is requesting the BOD consider the rental of a 5'X10' storage unit for additional equipment, supplies, etc.
 - i. Cost is \$128/month + tax for 5X10' unit







- ii. Reason for additional storage
 - 1. New Sport NB storage is much smaller than our old space
 - 2. SNB has exceeded the space at Sport NB we've be allotted already
 - 3. SNB has a lot of items coming over the next few weeks/months to store
 - a. Provincial Team Jerseys
 - b. Equipment
 - c. Helmets
 - d. 40 dozen balls
 - e. Rule Books
- iii. Being stored in the additional space would be items that are not used on a regular basis.
 - 1. Additional Caravan equipment / shirts
 - 2. Equipment
- b. Hillary Pineau recommends renting this storage space until the end of the year and we will re-evaluate our storage needs at that point.
- c. Motion to allow staff to rent a 5'X10' storage space, not to surpass \$2,000 per annum

 - i. The U13 Girls/Boys Eastern Canadian calls for hosts are out now. Deadline to apply is March 11th.
 - ii. Hillary Pineau asked for the Regional Directors to push this information out to their members
 - b. Qualifiers
 - i. Hillary Pineau is recommending to the BOD that SNB should return to Moncton for the female qualifier for 2022 and revisit the January Qualifier Proposal for 2023 to target new areas for growth. This is due to the short timeline, planning process, and the amount of stuff SNB has scheduled for 2022. Victor Bastarache has 5 fields booked for the event. The male qualifiers will occur in Region 3







- ii. The rest of the January Qualifier Proposal (Registration Fee, Awards, etc) will occur in 2022.
- 9. Revitalization plan for pitching program
 - a. Bobby Despres and Matt Whipple will be working together to develop a framework to develop a sustainable pitching instructor program. This framework will unify the pitching instruction being taught across the province, will identify key individuals to hold sessions, develop consistent costs, times, and lesson plans.
