A \$50.00 fine would be issued for every late stat within three days of the game. That way we don't have kids running away with penalty minutes and eventually someone gets hurt. I seen we had a few kids starting to get a little rough last year so I put the warning out and maybe it was coincidence but their minutes drastically fell after that. It's a great game and a lot of fun we - should keep it that way. Thanks.
