Tiering Policy

Goal is to start the season as even as possible, though there can be separation at the end and that is due to coaching, player commitment on and off the ice etc.

Recommendations:

- RAB ownership of association tiering requirements
- Electronic game sheets province wide
- Number of tiers should increase to improve competitive play
- Ringette albert to use a database approach to tiering
- U10, U12 and U14 continue to use UAA
- RAB to consider rebranding tiers (how does this impact extra provincial play?)
- Balanced team requirement for multiple teams in a tier
- Mandatory re-tiering reviews after session 1 and 2
- Participation >60% of league games for post season play
- AA becomes a program instead of a tier
 - Any league games that cross AA/A like U16AA and 19A should account for a 0-0 score so as to not impact the tiering statistics.
- AA programs should align provincially

RAB Path Forward

New Board forms

- Reconstitute same committee
- Board discuss how to turn this into a policy
- This is a big change
 - o Creating pilot programs (pick one division rather than full scale change)
