## (E) AA DISCUSSION

Phasing out of AA program within next few years by RAB. Introduction of Pursuit of Excellence (POE). 2022/2023 season, associations will not host U14AA team, associations will have two "U14A" teams if they had one "U14A" team in previous season. 2022/2023 season would have "double-carded players" who would play POE and home association. Ongoing discussion with RAB and associations. SGRA would have both U16AA & U19AA team for the 2022/2023 season. Associations will not have "AA" teams in future, Pursuit of Excellence will replace this level of play within associations. Discussion of AA policy - should import/outside players be allowed to play for SGRA if they fall within AA rankings (not within top 15%), should numbers be limited (accept # out of total skaters)?
