- Half ice practice and team is short by amount of players they are looking to affiliate for practice. For example, if team size is 13 and 1 player is missing team may affiliate 1 player for a half ice practice.
- All efforts are made to rotate affiliates

Third Offense: Three (3) game suspension of Head Coach or Acting Head Coach pending investigation of the infraction. Any further infractions beyond the third offense in the same playing season will result in removal of head coach privileges and may not be limited to selection as a head coach for a future season."
