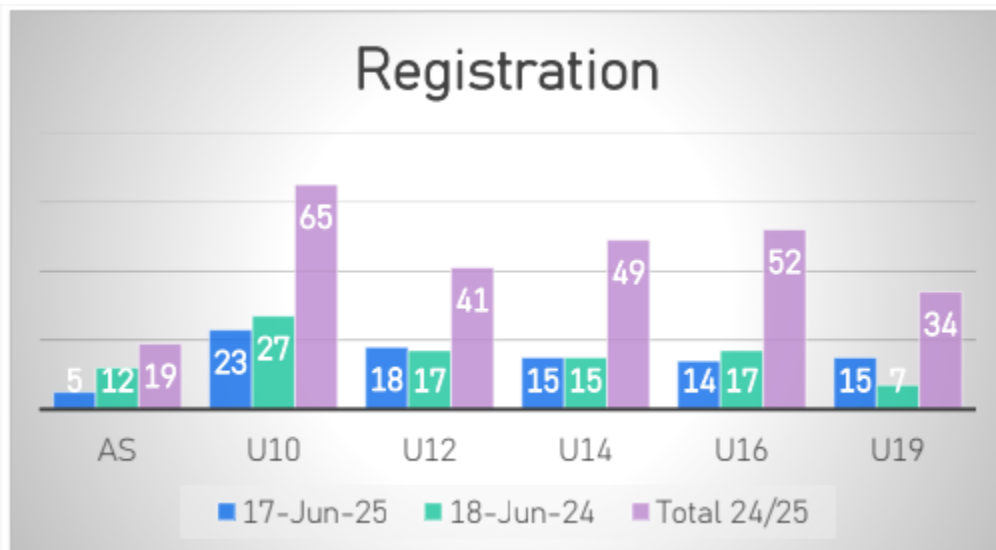

Waiting on ice availability and will finalize once those details are in place. Ideally, we would like three back to back slots Aug 25th

- 27th so that evaluators/ volunteers are not required to

relocate or wait longer than necessary those evenings.

Would also like to explore ice opportunities for Aug 23/24 for a goalie evaluation and/or U14AA UAA related skates.

Evaluation scrimmages have been booked for our U16AA (6:30-7:45 pm) and U19AA (8pm-9:15pm) with Edmonton Ringette Club the evening of Thursday, August 28th at Castledowns

Arena. ERC will cover the cost of ice and we will be splitting the cost of refs.

We do not have plans to schedule tryouts over the long weekend. We expect A,B,C tryouts to begin after the long weekend and wrap up by the 3rd week in September (same as previous years). More details to come as we receive available ice options.

I have spoken to Justin Reynolds from Sports Evaluations regarding the tentative dates so that he is able to begin securing his evaluators. (This is our final year on contract with Sports Evaluations).
